25.4 The remaining ten percent (10%) of the contract value (not considering the quoted value of the L1 vendor towards provision of Engineers for 5 Years) shall be released annually over a period of five (05) years, at the rate of two percent (2%) per year, subject to Provision of stipulated post-contract support services & Deployment of resident / specialist engineers, as per the contract, with satisfactory performance duly certified by the User.

**26. Technical Compliance, Guidelines & Framework.** This is a mandatory document to be uploaded by all bidders as part of Technical bids. The document is attached below as buyer added bid specific ATC below at Para 39 of bid document.
