1. Invitation

Part-I: Annexure-1 is mandatory submission. It contains EMD of amount Rs.10,000/- (Rupees Ten Thousand only). Vendors registered under NSIC/MSME and others who are exempted from EMD as per rule by Govt. of India and MP Govt.

Part-II: Annexure-2 & 3 should contain "Technical Tender Form". This part of the tender shall contain bidder profile, eligibility for the agencies, as well as technical specifications. Attach separate sheets wherever required. If there is any deviation in specifications of material/ items/ services, notify with complete details. The Institute reserves the right to decide on such deviation/s. This envelop should not contain any price information.

Part-III: Annexure-4 should contain Price Bid (Financial bid) only.

2. Price Bid (Financial Bid)

- 2.1. Bid price shall be considered as itemized unit price inclusive of all taxes, service charges etc. Bidder must quote clearly a single unit price for each item. Format of price bid is enclosed with document and annexed as Annexure -2.
- 2.2. All duties, taxes and other levies payable by the contractor under the contract shall be included in the total price.
- 2.3. The prices should be quoted in Indian Rupees, inclusive of taxes, service charges etc.

3. Validity of Tender

The Tender shall remain valid for a period of **TWELVE** months or 365 Days as per the order, and also institute have the right to increase or decrease or nullify the period of validity of tender. The Institute reserves the right to accept or reject any tender or to reject the bidding process wholly or partly without assigning any reason.

4. Evaluation of Bid

The Institute will only evaluate and compare the bid determined to be substantially responsive i.e. which

- Are complete as per instructions given and signed;
- Confirm to the terms and conditions, and technical specifications.
- Previous supply orders of the equipment with price from IITs/NITs/Govt. Institutes/PSUs/Private institute etc. must be submitted in envelop
- The bid shall be published in two parts:
 - (A) **Technical Bid**
 - (B) **Financial Bid**
- Only those service provider firms/bidders who are found successful in the Technical Bid evaluation shall be eligible to participate in the Financial Bid.

a. As part of the technical bid evaluation process, the bidder shall be required to present the materials/work samples/brochure/product detail for inspection before the Committee on the date and time specified by the Institution. The inspection will be carried out by the Committee, and only those bidders whose materials/work quality is found satisfactory and in accordance with the prescribed standards shall be considered Technically Qualified. Only the Financial Bids of the bidders who are technically qualified will be admitted in financial evaluation. The date, time, and venue for the inspection will be communicated to the bidder through the registered e-mail ID provided in the bid.

*b. **Mandatory Confirmation of Rates:** After the opening of financial bids, the bidder(s) identified as L1 (Lowest-1) for various items/categories must submit a Written Confirmation/Acceptance/justification Letter. In this letter, the bidder must explicitly undertake to supply all the items (as per specification) at the rates quoted by them in the financial bid without any deviations.*

*c. **Penalty for Non-Submission of Confirmation:** If the L1 bidder fails to submit the written confirmation after the financial evaluation, their bid shall be summarily rejected. The bidder shall be debarred from participating in any future tenders/procurement of this Institute for a period of 2 (Two) Years.*

5. Award of Contract

The Institute will award the contract to the bidder whose quotation has been determined to be substantially responsive (technically & commercially) and who has offered the lowest evaluated quotation price.

5.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any financial bid and to cancel the bidding process and reject all quotations at any time prior to the award of contract.

5.2 The bidder whose bid is accepted will be notified of the award of contract by the institute prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the order.

5.3. Performance Obligation and Blacklisting: Once the Contract/Purchase Order is awarded based on the accepted rates, any refusal or denial by the vendor to supply the products shall be treated as a **Breach of Contract**. In such an event: The firm shall be **Blacklisted** from all future procurement processes of the Institute.

ANNEXURE - 5

ELIGIBILITY, TERMS & CONDITIONS OF CONTRACT

1. Eligibility (Particulars of documents for eligibility):
