TERMS & CONDITION

I) Specifications :-

The bleaching powder to be supplied should be of Shriram Grade I or Equivalent . The rates quoted for any other brand shall not be considered for comparing and such tenders shall be rejected summarily.

II. Earnest Money Deposit :- The tenderer shall have to furnish earnest money deposit EMD payable through online payment Gateway on portal (<https://eprocure.goa.gov.in>) through NEFT/RTGS mode only in the Account of , “Sports Authority of Goa” Panaji Goa. The tenders without earnest money deposit for Rs.36,000/- will summarily be rejected. The earnest money deposit of unsuccessful tenderer shall be refunded. The E.M.D. of the successful tenderer will be retained till end of the term of Tender. The earnest money shall be forfeited to the SAG in case of breach of any of the conditions governing the supply. If any tenderer withdraws the tender after submission, his / her EMD will be forfeited to SAG.

III. Delivery of Goods :-

The successful tenderer shall arrange to supply the material at the different Taluka offices and also to the SAG Store at SAG Store at H.O. Atal Stadium St.Cruz without any additional charge towards packing, forwarding, freight, etc.

IV. Time Limit for supply :- The materials should be delivered within 10 days from receipt of the supply order or within short notice, depending upon the situation. Any of the materials received in broken or damaged condition the same will have to be replaced by the successful tenderer without any additional cost and within the stipulated period. Any cost incurred on transportation of damaged goods will have to be borne by the supplier.

V. Validity :- The rates quoted by the tenderer shall be valid for one year from the date of opening the tenders. The Validity can however be extended with mutual consent. The rates quoted should be inclusive of taxes, levies, duties, Transportation and other incidental charges, if any. No separate tax or such additional charges will be paid by SAG.

VI Arbitration :- The decision of the Executive Director, Sports Authority of Goa as to whether the goods conform or not to the respective specifications or whether the same are of good quality or not, shall be final and binding on the successful tenderer.

VII. Sub-standard Materials :- If the material is not conforming to the specifications given by SAG or if it is found that the material supplied by the tenderer is not of good quality or of different brand, the same shall be rejected summarily and the tenderer shall be responsible for this lapse, with consequential damages.

VIII. Penalty for delayed supply :- In case the supplier fails to deliver the material according to the supply order which is placed with him, within the prescribed time limit, he shall be liable to pay to the SAG, liquidated damages, amounting to Rs. 500/- for each day of delay.

IX. Payment Terms :- The payment against the items delivered shall be made after the same are accepted, for which stamped pre-receipted bill drawn in favour of Executive Director, SAG, in triplicate indicating the **GSTIN NO**, shall have to be submitted to the SAG office by the Supplier, together with the delivery challan /acknowledgement receipt, to the effect that the materials have been received in good condition and as per the approved brand / specifications.

X. Disputes :- Disputes arise, if any, will be subject to the jurisdiction of courts established at Panaji – Goa. The Executive Director, Sports Authority of Goa, reserves the right to accept any, in full or part or reject all the tenders including the lowest, without assigning any reasons thereof.
