FOR ONLINE TENDERING at <https://etenders.gov.in/e procure/app> Sealed percentage rate/Item Rate tenders are invited for the execution of the following works by the MCD from approved and eligible contractor and will be received as per time table at site <https://etenders.gov.in/e procure/app> in the presence of contractors, if any. The registered contractors of MCD and all contractors registered with CPWD, State PWDs, Urban Local Bodies and other Government Departments in their respective categories in addition to the contractors registered with MCD, to participate in the tendering process of Municipal Corporation of Delhi by registering themselves on E-Tendering website: <https://etenders.gov.in> are eligible to tender for the amount they have registered in their respective category subject to the conditions that they are neither black listed nor debarred at the time of purchase of tenders. In case of holiday is declared on the date of said schedule it will be done on the next working day. The tender will be opened in the office of Executive Engineer(M)-III, LIG Flats, East of Loni Road, Shahdara, Delhi – 110093.

Conditions given in the printed NIT form A-32, Chapter 9 of the Municipal Accounts Code Part I will hold good. The contractors will have to give a declaration about the name of t

heir relatives employed in MCD along with each tender.

Bidding Documents may be downloaded from online at website - <https://etenders.gov.in/e procure/app> payment for cost of bidding document and earnest money may be paid before download of tender document through Online Payment. The desirous contractors shall have to pay the cost of document and Earnest Money mentioned against the work at the time of Purchase and download of tender document.

Both Tender cost and Earnest money can be deposited in the form of Online Payment of a scheduled Bank in favour of Commissioner, MCD. The validity of rates hold good for 5 Months.

Cement will be procured by the contractor for all works as per circular issued in this regard. Contractors will be required to arrange bulk/paced bitumen for the road work directly from the Bharat Petroleum Indian Oil Co. Hindustan Petroleum himself and produced the bills/ vouchers etc. as proof thereof. No receipt form any agent/dealer shall be accepted. In case of negotiations the period of validity of rates will be counted from the date of negotiation. The department has right to postpone/cancel the NIT without assign any reason The date & time of different activities of tendering process may be checked on the MCD website <https://etenders.gov.in/e procure/app> time to time. Quality testing of work will be carried out as per circular No. D/EE(P)-III/409 & 410/2005-06 dated 27.07.05 amended vide circular No. D/SE (QC)/2006/1571 dated 25.10.06 and amended time to time in future.

Deduction of GST/VAT at source shall be made as per rules. As per circular No. F.506/E-in-C/204/1015 dated 20.04.2004, if the rate quoted by the lowest tenderer are found abnormally low the payment to the contractor for the work shall only be made after inspection by the Quality Control Cell at different stages and these findings shall be final and binding on the contractor. All the testing charges from the independent laboratory shall be borne by the contractor. In case, the lowest contractor fails to commence/complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per the provision of the enlistment rule/instructions issued from time to time. The tenders will also be received through E-Tendering. Revised rates Earnest Money, Security Deposit:

A. Cost of work up to 25 crores 2% of the estimated cost of the work.

B. Security Deposit: A sum of the rate of 10% of the gross Amount of R/bill shall be deducted from each running bill of the contractor till the sum along with sum already deposited as earnest money will amount to security deposit of 10% of the value of the work (Bank Guarantee is not to be accepted as security deposit).

The facilities of G.E.M. as circulated by E-in-C vide circular No. D-29/SE-I/dated 12.03.96 stands withdrawn

1% of Labour Cess will be deducted in the bill.

Circular No. D/90/EE(P)/2012-13 dated 07.08.2012 w.r.t. amendment to General Conditions of contract 10CA in supersession of earlier orders issued vide Circular No. D/EE(P)-III/27/2006-07 dt. 19.05.06 is applicable and read as Addition to clause 7, clause 9 and 9A regarding payment of bills to contractors. Cash less payment will be made by contractor to the labour deployed at work. Circular No.D-229/DCA/HQ/EDMC dated 14.12.2016, ongoing financial crisis in MCD and similar matter being subjudice in court of Law regarding payments it is clarified that payments will only be release on availability of funds under head of account 89/1157 and other non-plan heads shall be applicable. Circular No.CE/SH/S/D-364 dated 23.01.2017, Malba and C&D Waste will be dump at Waste Plant Shastri Park G.T. Road Shahdara. Circular No.EDMC/EE(plg.)2017/D-200 dated 13.10.17 "A Kaccha space of size 6feet x 6feet shall be left open around every existing tree so that the tree could get proper water and nourishment. The circulars No. CA/F&M /2015/D-145 dated 05.11.2015 issued by the CA cum FA shall be applicable to these

tendering cases and will be a part of this NIT. In reference to subject regarding relaxation for Earnest Money deposit, the circular issued vide letter No.SE(Plg.)/MCD/2021/D-23 dated 10.03.2021 is hereby withdrawn with immediate effect, vide office order No.SE-Plg/MCD/2021/D-19 dated 21.12.2021. No extra payment or deduction shall be made in case there is variation in rates of these product/ material. It has been made mandatory by the National Disaster management authority (NDMA) Government of India (GOI) for the bidders to refer Vulnerability Atlas of Indian for multi-hazard risk assessment and include the relevant hazard proneness specific to project location while planning and designing conveyed by circular No.EE(Plg)/MCD/2021/D-209 dt.28.07.2021.

#### **Modification in Para 5.2 of CPWD work Manual 2024.**

Circular vide No. Vidyut Bhawan, New Delhi Dated 27.02.2026 and Addl. Comm.(Engg.)/MCD/2026/D-88 dated 18.03.2026

The contractor shall submit an irrevocable Performance Guarantee of 5% (Five percent) of the tendered amount in addition to other deposits mentioned elsewhere in the contract for his proper performance of the contract agreement, (not withstanding and/or without prejudice to any other provisions in the contract) within the time stipulated in the special conditions of contract. If contractor fails to furnish the prescribed performance guarantee within the prescribed period, the earnest money is absolutely forfeited to the President automatically without any notice.

#### **Condition: -**

1. The outside registered contractor who wish to participate in the tendering process in MCD shall submit a copy of their registration certificate in which they are registered to the concerned division as well as to office of ADC (Engg.) HQ.
2. An affidavit on a non judicial stamp paper of Rs. 100/- (not older than one month) from last date of submission of bid) shall be submitted by the outside registered contractor with each tender swearing therein that the agency is not blacklisted / debarred by any Govt. / PSU of Private organization.
3. The outside registered contractors who wish to participate in tendering process of MCD shall submit their registration certificate to Engineer Department (HQ) along with an affidavit as mentioned at Sl. No. 2 above.
4. Engineering Department (HQ) shall accordingly prepare a data base of the outside registered contractors and circulate the same to all divisions of Engineering Department.
5. The division of Engineering Department where the outside registered contractor has participated in the tender process shall confirm the status of the contractor regarding validity of his registration from Engineer Department (HQ), MCD before processing the case further.
6. The status of MCD registered contractor regarding revalidation of his enlistment in MCD shall also be got confirmed by the concerned division from Engineer Department (HQ).

**SPECIAL CONDITIONS AS PER DIRECTIVES OF HON'BLE NATIONAL GREEN TRIBUNAL AND EIA GUIDANCE MANUAL.**

1. The contractor shall not store/dump construction material or debris on metalled road.
2. The contractor shall get prior approval from Engineer-in-Charge for the area where the construction material or debris can be stored beyond the metalled road. This area shall not cause any obstruction to the free flow of traffic/ inconvenience to the pedestrians. It should be ensured by the contractor that no accidents occur on account of such permissible storage.
3. The contractor shall take appropriate protection measures like raising wind breakers of appropriate height on all sides of the plot/area using CGI sheets or plastic and or other similar material to ensure that no construction material dust fly outside the plot area.
4. The contractor shall ensure that all the trucks or vehicle of any kind which are used for construction purposes or are carrying construction material like cement, sand and other allied material are fully covered. The contractor shall take every necessary precaution that the vehicles are properly cleaned and dust free to ensure that enroute their destination, the dust, sand or any other particles are not released in air/contaminate air.
5. The contractor shall provide mask to every worker working on the construction side and involved in loading, unloading and carriage of construction material and construction debris to prevent inhalation of dust particles.
6. The contractor shall provide all medical help, investigation and treatment to the workers involved in the construction of building and carry of construction material and debris relating to dust emission.
7. The contractor shall ensure that C&D waste is transported to the C&D waste site only and due record shall be maintained by the contractor.
8. The contractor shall compulsorily use of wet jet in grinding and stone cutting.
9. The contractor shall comply all the preventive and protective environment steps as stated in the MOEF guidelines, 2010.
10. The contractor shall carry out on Road inspection for black smoke generating machinery. The contractor shall use cleaner fuel.
11. The contractor shall ensure that all DG sets comply emissions norms modified by MOEF.
12. The contractor shall use vehicles having pollution under control certificate. The emissions can be reduced by a large extent by reducing the speed of a vehicle to 20mph. Speed bumps shall be used to ensure speed reduction. In case where speed reduction cannot effectively reduce fugitive dust the contractor shall divert traffic to nearby paved areas.
13. The contractor shall ensure that the construction material is covered by tarpaulin. The contractor shall take all other precaution to ensure that no dust particles are permitted to pollute air quality as a result of such storage.
14. The paving of the path for plying of vehicles carrying construction material is more permanent solution to dust control and suitable for longer duration projects. The NIT approving authority shall carry out cost benefit ratio analysis of the same.
15. All the conditions of MLALAD/MPLAD/MSPYLAD/Councillor Local Area Development Fund Scheme etc. are also applicable.
