4.1	Bidders can prepare & edit their offers number of times before tender submission date & time. After tender submission date & time, bidder cannot edit their offer submitted in any case. No written or online request in this regard shall be granted.
4.2	Tenderer shall submit their offer i.e. price bid in Electronic format on above mentioned website & Date shown above after Digitally signing the same.
4.3	Offers submitted without digitally signed will not be accepted.
4.4	Offers in physical form will not be accepted in any case.
5.0	Submission of Tender Fees, Bid Security and other valid Documents:
5.1	Tender Fee : Rs. 3600 by Demand Draft in favour of Executive Engineer Rajpipla R&B Division Rajpipla from any Nationalized/Scheduled Bank except Co-operative Bank. Demand draft issued after the last date of submission of Bids will not be considered or accepted.
5.2	Bid Security i.e. EMD: Rs. 131000/- in the form of FDR in favour of Executive Engineer Rajpipla R&B Division Rajpipla from any Nationalized / Scheduled Bank except Co-operative Bank. BG shall be valid up to 180 Days. FDR issued after the last date of submission of tender will not be considered as valid or accepted in any case. Bank Guarantee from any scheduled Indian bank, in the format given in Volume III.
