The conditions as given in the printed NIT form A-32, chapter-IV, Municipal Accounts code, Part-I will also hold good. Conditional tenders shall be not accepted. All the applicable taxes will be paid by the contractor. If the rates quoted by the lowest tender are found abnormally low, the payment to the contractor for the works shall only be made after inspection by Quality Control Cell at different stages and the findings shall be final and binding on the contractor. All the testing charges from the independent Laboratory shall be borne by contractor. In case the lowest contractors fails to commence/complete the work within the stipulated period, the contractor shall be liable for disciplinary action per provisions of the enlistment rule/instructions issued from time to time. The testing of the works/supplies shall be got done in accordance of office circular No. CVO/Vig./05/2289 dt. 17.05.05 and charges of test also be borne by the contractor accordingly. Circular No. E.E.(P)-III/2005-06/D-398 dt. 17.06.2005 is applicable the cement and steel will be procured by the contractor as per terms and conditions of NIT. In case of holiday the tenders will be sold/issued/received on the next working day. The responsibility of correctness and genuineness of all the documents submitted by the contractor solely lies on the contractor. The competent authority on behalf of Municipal Corporation of Delhi does not bind himself to accept the lowest or any other tender, and reserves to himself the authority to reject any or all of the tender received without the assignment of a reasons. Govt. of Delhi of NCT of Delhi has framed "Delhi Building & other Construction Works (RE & CS) Rules 2002" which were notified in January 2002 and came into force since then. Thereafter "Delhi Building & Other Construction Workers Welfare Boards" has been constituted under the chairmanship of Minister of Labour & Employment, Govt. of Delhi vide notification dated 02.09.2002. Secretary (Labour), GNCTD vide Order No. 17(10)/BOCW/PG/Lab/05/207 dated 16.08.2005 and No. F.17(10)/BOCW/PG/Lab/05/45 dated 02.01.2006 provided details of the Act / Rule and circulated forms etc. for calculating cess on contractual work / department work / building plan sanction cases, modalities of making payment to welfare board and registration with Assistant Labour Commissioner.

These direction were circulated vide letter No. D/471/EE(P)III dated 22.02.2006 to all concerned for compliance. The following conditions shall also apply:

(i) Quality assurance/ Audit of works by the approved testing organization as per MCD resolution No. 573 dated 13.3.03 will be carried out and decision of the same will be applicable on the contractor.

(ii) The contractor himself as per terms & conditions of the department if any, will arrange Cement/ Steel. The contractor should have a valid Sales Tax No.

(iii) If the rate quoted by the lowest tenderer are found abnormally low the payment to the contractor for the work shall only be made after inspection by the Quality Control Cell at different stages and these findings shall be final and binding on the contractor. All the testing charges from the independent laboratory shall be borne by the contractor. In case, the lowest contractor fails to commence/ complete the work within the stipulated period, the contractor shall be liable for disciplinary action as per the provision of the enlistment rule/ instruction issued from time to time.

(iv) Circular No. D/4 /EE/ (P)-III/06 dated 7.3.06 regarding security deposit and Circular No. D/398 /EE (P)-III dated 17.6.05 regarding earnest money will be applicable. Circular No. D/SE (QC)/2006 / 1571 dated 25.10.06 regarding the quality assurance of work, circular No. SE(QC)/06-07/d-2816 & 2817 dated 20.2.07 regarding addition of due weightage in justification of rates, circular No. D/ EE (P)-III/27/ 2006-07 dated 19.5.06 regarding payment of bills to the contractors and office order No. D-167/ EE(P)-III/06-07 dated 11.12.06 regarding deletion of arbitration clause from general condition of contract shall be followed and applicable.

(v) 2% GST shall be deducted at source from the bills of the contractors as per Circular No. Addl.Cm.(FA&P)/F&G/NDMC/2017/D-37 dated 06.09.2017.

(vi) As per Circular No. EE (P)-III/471 dated 22.2.06, weightage @ 1.00% on aggregate value of work will be added for labour cess which is to be deducted from contractor on total cost of work order.

Bitumen shall confirm to grade and quality as specified in the nomenclature of items. Bitumen required for works shall be purchased and brought at site, by the contractor from approved manufacturer and stored properly. The contractor shall be required to submit the following document: -

- i) Photo copy of the invoice in duplicate from the manufacturer as a proof of procurement of fresh bitumen.
- ii) The name of the work shall be written by the contractor on the photocopy of invoice. The photocopy will be self-attested by the contractor certifying that this is a true copy of original invoice. This attestation will be done by the contractor in the presence of the Engineer-in-charge or Divisional Accountant.
- iii) One photocopy of the invoice, self-attested by the contractor will be given to Engineer- in-charge at site and other to Divisional Accountant.

As per the circular no.08/EE(P)III/NDMC/2012-13 dated 27.11.2012, the Amendment to General Condition of contract Clause 10CA will be applicable as per CPWD Works Manual. The modified condition of contract clause 10CA and the table of materials to be inserted in Schedule 'F' for clause 10CA.

As per the circular no. D-25/EE(P)-III/NDMC/2012-13 dated 19.03.2013, the Amendment to General Condition of contract. "The goods including for works contract, shall be supplied by bidder or its authorized distributor in Delhi and against a sale invoice issued from Delhi. The delivery of goods shall also be made from Delhi. The bidder dealer or its authorized distributor, as the case may be, who supplies the goods should be registered with the Delhi Vat department and carry a valid Tax identification Number issued by it. The bidder shall, however, be responsible for compliance with all conditions, warranties / guarantees, irrespective of the fact that the goods are supplied by him directly or through its authorized distributor. Further, the quoted bid price in the tender shall be inclusive of all taxes and duties."

- (1) (i). If any tenderer withdraws his tender or makes any modification in the terms & conditions of the tender which is not acceptable to the department within 7 days after last date of submission of bids, then the Government shall without prejudice to any other right or remedy, be at liberty to forfeit 50% of earnest money absolutely irrespective of letter of acceptance for the work is issued or not.  
(ii). If any tenderer withdraws his tender or makes any modification in the terms & conditions of the tender which is not acceptable to the department after expiry of 7 days after last date of submission of bids, then the Government shall without prejudice to any other right or remedy, be at liberty to forfeit 100% of the earnest money absolutely irrespective of letter of acceptance for the work is issued or not.
- (2) If contractor fails to furnish the prescribed performance guarantee within the prescribed period, the earnest money is absolutely forfeited to the President automatically without any notice.
