**Pre-Qualifying Requirements (PQR):**

### Scope of work


1. The service provider shall provide AC commercial taxi vehicles of first registration of 2024 or later as per the categorization mentioned in Annexure VII.  
The vehicles shall be provided at our office premises at BHEL Lodhi Road, New Delhi or at any other place intimated to the Service Provider for travel within or outside Delhi/ NCR as and when required and on monthly basis.
2. BHEL expects that the service provider shall have all types of vehicles as per the details in Annexure VII in ready/working condition for providing services.
3. **The anticipated business volume during the contract period of two years towards hiring of vehicles shall be approx. Rs. 161 Lakhs (Exclusive of GST) in respect of BHEL Industry Sector, IO & ROD units at Lodhi Road, New Delhi.**
4. The above figure (**Rs. 161 Lakhs**) is indicative for tender purposes only and does not guarantee the business volumes for the contract period of two years. This may increase or decrease depending upon actual requirements.
5. The Service Provider shall provide drivers holding **valid driving license** and adequate knowledge of reading, writing and spoken English / Hindi. The drivers should have knowledge of different routes and should be able to carry out minor repair work in vehicles, if required. The reporting time, place, address etc. should be strictly followed by the Service Provider.
6. **Uniform:** Drivers should be neatly dressed in the taxi driver uniform along with shoes.
7. **Conduct:** The drivers deputed for duty should be polite, well behaved and must possess positive attitude in discharging their duty. Chewing of tobacco, smoking and drinking while on duty will not be tolerated and will be treated as misconduct and any liability arising due to this will be borne by the Service Provider.
8. The vehicle provided by the Service Provider must be in excellent condition and must have proper and complete documents. The vehicles should comply strictly with the provision of pollution control in line with the directions of Supreme Court from time to time and should also comply with statutory regulations issued by respective State Transport Authorities / Central Govt. BHEL shall in no way be responsible for any liability arising due to non-compliance of statutory requirements / regulations w.r.t. the vehicle as well as the driver.
9. The Service Provider must ensure that the driver of the vehicle sent for duty is provided with a mobile phone.
10. In case of non-availability of requisitioned vehicle, it will be the responsibility of the Service Provider to provide equivalent or higher segment vehicle (model not older than 2024 at the same rates).
11. The Service Provider shall maintain a duty slip / log sheet (for vehicles deployed, on monthly basis / as and when required basis) as per Performa enclosed (refer Annexure VIII & IX). The driver should get the log sheet / duty slip signed by the user at the end of each journey which would indicate the details such

as starting and the closing meter reading, point of start / end of the journey, places visited, date and time of reporting / release of vehicle etc.

25 hard copies and a soft copy of Duty slip along with the letter of award of contract and log book will be provided by BHEL. However further duplication of those duty slips will be the responsibility of the Service Provider.

12. Before replacing either the monthly vehicle or driver, prior permission for the same may be obtained from BHEL.
13. Generally, a prior notice of two hours will be given to the Service Providers for providing / arranging the vehicle.
14. At times, when the hiring of the vehicle is for top management official of BHEL / VIP customer, BHEL reserves the right to inspect the vehicle prior to confirming the booking.
15. **Charges on the principle of "Garage-to-garage" basis as per actual distance will be permissible in respect of the journeys starting from places, other than BHEL Lodhi Road, New Delhi.**  
**However, for journeys starting from and up to BHEL Lodhi Road, garage-to-garage KMs for each side would be restricted to maximum of 8 KMs or the actual distance between BHEL, Lodhi Road and the garage of the Service Provider, whichever is lower.**  
**\*In future, if BHEL Lodhi Office is relocated to Sector 16 A, Noida, the garage-to-garage KMs for each side would be restricted to maximum of 15 KMs or the actual distance between BHEL, Sector 16 A Noida and the garage of the Service Provider, whichever is lower.**
16. In respect of hiring of vehicle on as and when required basis, the computation of duty hours shall be from the time of reporting and the time of its release, duly signed by the user. This requirement is mandatory for processing the bill for payment. However, in respect of hiring of vehicle on monthly basis duty hours shall be calculated on garage to garage basis.
17. Vendor shall ensure at all times, proper hygiene, cleanliness and periodic maintenance of vehicle.
18. Vendor's driver will be responsible to obey traffic rules and BHEL in no way will own any responsibility in this regard.
19. An up-to-date First Aid Kit should always be available in the vehicle for use in case of requirement. With regard to safety, vendor shall ensure that a suitable Fire Extinguisher shall remain in vehicle for any emergency.
20. It should be the sole responsibility of Vendor to ensure that the vehicle is/are always and exclusively driven by a person appropriately qualified and licensed under the Motor Vehicle Act.
21. Vendor shall ensure that the vehicle should always have sufficient fuel in tank for running of during the day. Refuelling trip shall not be permitted during the duty unless agreed by BHEL.
22. The vendor shall maintain all necessary records of the drivers deployed for the work in proper format with necessary proof. The records shall be maintained with relevant details of domicile, education, residential address, mobile no., recent passport photograph, police verification certificate etc.
23. Vendor shall ensure that the driver has sufficient money enabling him to pay for fuel, parking, toll tax & other sundry expenses.

### Special Conditions of contract

#### **1. Rate & price variation:**

In case of award of contract, the hiring charges shall remain firm for a **period of two years i.e. the ENTIRE PERIOD OF CONTRACT** except price variation due to increase / decrease in the price of fuel (normal diesel as available at Petrol Pumps in Delhi) which shall be calculated based on variation in the price of diesel as per formula given below. BHEL would allow price variation due to increase / decrease in diesel rates (60% component) as per below mentioned formula:

$$\text{\% Increase / decrease in hiring charges} = \frac{[\text{Revised rate of diesel - base rate of diesel on the last date of original tender submission}] \times 0.60 \times 100}{\text{Base rate of diesel on the last date of original tender submission}}$$

The revision of price of hiring of taxis shall be made effective from 1st day of the month subsequent to the month in which fuel prices have been revised by Govt.

**Note:** The price of diesel per litre as on last date of original tender submission will be considered as base price for PVC.

#### **2. Validity of offers:**

The offers submitted by the parties shall be valid for 80 days from the date of opening of Part-I bid. Price bid opening shall be limited to techno-commercially acceptable bidders only. Further, BHEL reserves the right to reject the offer of bidder(s) without assigning any reason.

#### **3. Validity of contract:**

The contract will be valid for a period of two years. The same may however be extended further for a period of three months/part thereof with mutual agreement, in writing, on the same Rates, Terms and Conditions etc.


#### **4. Quantity Variation:**

The quantity of business volume mentioned in the tender is indicative only and may vary as per actual requirement.

The total contract price on account of quantity variation can vary from **+/- 30%** of the cumulative awarded value. Further, there shall be no compensation for any reduction in the overall contract price.

#### **5. Termination of contract:**

If at any time the Service Provider defaults in proceeding with the work with due diligence and continues to do so or commit any default in complying any of the tender terms and conditions even after the notice in writing is given, BHEL may, without prejudice to any other right to remedy which

shall have accrued or shall accrue thereafter to BHEL, terminate the contract by giving 15 days' notice in writing. The notice will be deemed to have been served as and when sent to the address given in the tender.

**BHEL also reserves the right to terminate the contract at any point of time without assigning any reason thereof.**

**6. Recovery from Contractor:**

Whenever under the contract, any sum of money shall be recoverable from or payable by the contractor, the same may be deducted from any sum then due or which at any time thereafter may become due to the contractor under the contract or under any other contract with BHEL or from his security deposit, or the contractor shall pay the claim on demand without any terms & conditions.

**7. Security deposit:**

Security deposit (SD) amount of Rs. 1,00,000.00 shall be deposited by the successful bidders through NEFT either within seven days from the date of award of work or before start of contract whichever is earlier. SD can also be recovered at the rate of 10% from the running bills. However, in such case at least 50% of the SD shall be deposited within specified time and balance 50% may be recovered from the running bills.

If the successful bidder requests BHEL in writing to adjust EMD amount towards SD then EMD shall be retained as SD. SD, without interest, shall be refunded after successful completion of contract period.

**8. Business distribution:**


BHEL intends to distribute **the work load to 03 Service Providers / agencies with larger share to the lowest bidder, i.e. the L1 bidder will be apportioned 40% of the business volume and the remaining 60% would be shared equally (i.e. 30% of the total business) by L2 and L3 bidders at L1 rates.** However, if any of the L2 or L3 bidders or both do not accept the work as per evaluation criteria then the lowest rates shall be counteroffered to L4 bidder and so on unless the work is awarded to three successful bidders.

**In the event of acceptance of L1 rate by only one qualified bidder (other than L1 bidder), distribution of work shall be done amongst two qualified bidders in the ratio of 50:50.**

**BHEL may allocate the total work (100%) to L1 bidder if no other bidder gives acceptance to work on L1 rate.**

This shall further be subject to availability of the required vehicles, reliability of services, and dependability of the Service Provider in providing the required services.

The vehicles sent to our office on our requisition shall have all relevant documents like Registration Certificate / Driving License / Insurance / Road Tax Receipt / Border Tax / Non-Polluting vehicle certificate/Fitness Certificate etc. The vehicle should be licensed and shall conform to all Govt. ## 9. Evaluation criteria:

- a. The techno-commercial bids submitted by all the bidders will be evaluated first. After techno-commercial evaluation, only the price bids of the qualified bidders will be opened on GePNIC Portal.
- b. Bidders are requested to read the “Notes” provided in Price Bid very carefully before filling up the price bid format. Offer containing incomplete price bid shall be rejected and will not be considered for further evaluation.
- c. Lowest bidder shall be identified on the basis of quoted value i.e. the sum of all 5 values of column BB of BOQ (Price Bid Format).
- d. For identification of overall L1, L2, L3 bidders, the evaluation will be done on the basis of the following formula:

$$\text{Quoted Value formula} = [0.43*\{(A*a) + (B*b) + (C*c)\} + 0.57*\{(D*d) + (E*e)\}/f]^*$$

First **0.43** indicates that 43% of the expenditure shall be incurred for taxis hired on “**as and when required**” basis.

Among the taxis hired on **as and when required** basis

- i. **a = 0.59** indicates that 59% of the total taxis shall be middle segment taxis like Swift Dzire, Etios etc.
- ii. **b = 0.31** indicates that 31% of the total taxis shall be deluxe segment taxis like Ciaz, Honda City, Verna etc.
- iii. **c = 0.10** indicates that 10% of the total taxis shall be 6-8 seater taxis like Innova Crysta, etc.

Second **0.57** indicates that remaining 57% of the expenditure shall be incurred for taxis hired on monthly basis. Among the taxis hired on monthly basis

- i. **d = 0.75** indicates that 75% of the total taxis shall be middle segment taxis like Swift Dzire, Etios etc.
  - ii. **e = 0.25** indicates that 25% of the total taxis shall be deluxe segment taxis like Ciaz, Honda City, Verna etc.
- f = 26** = Nos. of days in each month.

The value of status will be considered up to three decimal places to arrive at distinct statuses of all bidders.

- e. The above formula is derived to rank the bidders on overall basis.
- f. **The Successful bidders (overall L1, L2 & L3) may be required to match the lowest rate quoted for every segment (A, B, C, D & E) among the rates quoted by L1, L2 and L3.** After finalization of L1, L2 and L3 bidders, the work shall be awarded in the proportion as mentioned in Sl. No. 8 of Special Conditions of Contract.

**In the event of more than one L1 bidder, all L1 Bidders will be given opportunity to offer discount on Quoted rates. In case of tie even after offered discount, L1 bidder will be decided by lottery.**

### General Conditions of contract

#### **1. Arbitration:**

- a) In case amicable settlement is not reached between the Parties, in respect of any dispute or difference; arising out of the formation, breach, termination, validity or execution of the Contract; or, the respective rights and liabilities of the Parties; or, in relation to interpretation of any provision of the Contract; or, in any manner touching upon the Contract, then, either Party may, by a notice in writing to the other Party refer such dispute or difference to the sole arbitration of an arbitrator appointed by BHEL .

The Arbitrator shall pass a reasoned award and the award of the Arbitrator shall be final and binding upon the Parties.

Subject as aforesaid, the provisions of Arbitration and Conciliation Act 1996 (India) or statutory modifications or re-enactments thereof and the rules made thereunder and for the time being in force shall apply to the arbitration proceedings under this clause. The seat of arbitration shall be DELHI.
