- The Central Ministries/ Departments and other government buyers as applicable shall take cognizance of "Public Procurement (Preference to Make in India) Order 2017-Notifying CCTV/ Video Surveillance dated 6th March 2024, System for Security in furtherance of the Order" 5 " while procuring The surveillance devices i.e., CCTV Cameras (Analog/ IP/ Analog Speed Dome/ IP Speed Dome) should comply with the Essential Requirements (ERs) for security prescribed by MeitY to ensure the security of the VSS / CCTV systems, as per the Appendix 'A', as amended from time to time. The security testing report for CCTV/VSS is to be issued by the Standardisation Testing and Quality Certification (STQC) Laboratory or any other agency notified by MeitY from time to time. The validity of the test report issued by STQC Lab will be three years from the date of issue of the report. These Essential Requirements (ERs) for security of CCTV Cameras/VSS system will be enforced after 3 months from the date of issuance of this Notification. The security norms for the DVR and NVR will be notified subsequently." Accordingly, compliance regarding security testing report for CCTV/VSS issued by Standardization Testing and Quality Certification (STQC) Laboratory or any other

- b. Buyers are also expected to strictly ensure compliance with the MHA advisory issued by O.M. IV-24011/22/2020-Prov-I/270 dated 26 April 2024. Where in inter alia following is stipulated.
 - i. All Government agencies are advised that henceforth they may procure their CCTVs and allied solutions and hardware based on the Public Procurement Order 2017 and ensure the security of CCTV systems as mentioned in the above-mentioned notifications.
 - ii. Further, MeitY has issued an Advisory vide O.M. dated W-43/11/2021-IPHW dated 11 March 2024 on the Threat of Information through CCTV/Video Surveillance System (VSS)/Digital Video Recorders/Network Video Recorders. All Government agencies are advised to adhere to the guidelines outlined within the ambit of the Public Procurement Orders to safeguard the overall security and integrity of CCTV Cameras.
 - iii. Additionally, further notification from relevant government department or ministry pertaining to the aforementioned PPO is to be complied with.
 - c. Buyer is expected to apply all relevant filters against "Golden/Filterable" parameters to clearly define their technical requirements.
 - i. **For Procurement through BID/RA:** -One and only one value to be specified by the buyer against "Golden" parameters. Selecting "Any value" against GOLDEN parameters may result in incomplete specification in the bid and finally result in a vague contract. Accordingly any bid not having specific value against the GOLDEN parameters resulting in limited competition or higher cost to the exchequer or incomplete/ vague contract, the Buyer shall be solely responsible.
 - ii. **For Procurement through DIRECT/L1:**Buyers are advised to apply filters/ selections allowing all the values that are considered meeting or are better than their technical requirements. For any violation of the above, if resulting in limited competition or higher cost to the exchequer, the Buyer shall be solely responsible.

The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be $(\text{Increased quantity} \div \text{Original quantity}) \times \text{Original delivery period (in days)}$, subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

Any representation through a Dealer/ Distributor/ Subsidiary/ consortium shall not be treated as OEM. This has to be supported by necessary statutory documents. C CTV OEM should have manufacturing in India since last Five years and Foreign CCTV OEM should have manufacturing unit globally from last 10 Years.

"The CCTV OEM should have below ISO Certifications for Quality, Environment, Security management and Health & Safety Management system for manufacturing of all types of Cameras & NVR/ DVR. All the CCTV C omponents (Camera, VMS, NVR, DVR, etc) should be from same OEM for seamless integration and ease of operation. The Bidder/s shall attach the copy of the OEM's ISO Certificate along with the bid.

ISO9001:2015, ISO 14001:2015, ISO 27001:2013, ISO 45001:2018, IEC 27032:2012, CMMI Level 5 or above certification"

The Camera OEM should comply to General Data Protection Regulation (GDPR). OEM should have valid EP R (Extended Producer Responsibility License/ Authorization No. from Central Pollution Control Board for Electrical & Electronic Equipment E-Waste. OEM need to submit its certificate with technical bid.

The CCTV OEM should have its office and service/ support center in Maharashtra. Required sales, service tax number/ certificate to be provided along with the bid.

The CCTV OEM and product should not be from a country which shares a land border with India in compliance of the General Financial Rule 144 (GFR Rule No. 144) and CCTV OEM should be listed in Top 20 Security company of Security 50 by asmag.com. No Chinese OEM/origin products are allowed to participate.

To establish the reliability and credibility of the CCTV OEM, they must have supplied at least 200,000 IP CCTV cameras to any State Government, Central Government, or Public Sector Undertaking. Additionally, they must have fulfilled a single purchase order of at least 10,000 IP CCTV cameras for government schools in India within the last seven years, as of the bid submission date. Copies of purchase orders and corresponding supply evidence must be submitted as proof.

Tenderer should make insure that chinese brand is strictly restricted. Hence Make In INDIA certificate should provide.

OEM claiming Make In India must be ready to share the Manufacturing and Production plant details as and when asked by the tendering authority, this is to ensure that only genuine OEMs and not the importers/ dealers participate in this requirement-

Camera of only those make which have BIS, CE, FCC, RoHS, STQC certifications shall be eligible for participating in the tender.

The OEM should have cloud for plug & play remote viewing; the Cloud must be hosted in INDIA for protection of public privacy and related data from security threats.-

The OEM of the CCTV equipment's should not be debarred/banned/blacklisted or imposed sanctions by any Country or Government institution globally. OEM declaration to be submitted.-

OEM should have local service and support centre in Maharashtra for at least 10 years.

OEM Brand should have established in India at least for 10 years, its presence should be supported with brand.

Any OEM, which is having JV model business shall not be allowed to participate in the tender.

The Proposed CCTV OEM should be FULL Member of ONVIF (Open Network Video Interface Forum) and same will be cross checked online in ONVIF website. OEM should give the declaration about full membership.

The OEM of Camera and OEM of NVR should have a presence in India for the past seven years as on date of submission of the Bid.

- Copy of GST registration
- Copy of PAN Card"

OEM(s) of Camera and NVR should have a fully equipped repair and maintenance center in India as on date of submission of the Bid.

Details of Address and support phone number for India based Technical Support Centre, repair and maintenance centre (Self-Declaration)

The Service provider backbone should be highly redundant, ensuring that there is no single point of failure.

"Certification / Testing Report: The Bidder needs to provide the security testing reports for CCTV issued by standardization Testing & Quality certificate (STQC) notified by Meity.

Bidder/OEM must submit Material Test Report or OEM brochure or technical specification compliance as per specification along with Bid document."

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

4. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.

7. Seeking sample with bid or approval of samples during bid evaluation process. 12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

- All operative provisions of the erstwhile Labour Laws until their complete substitution.

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.

This Bid is governed by the General Terms and Conditions, conditions stipulated in Bid and Service Level Agreement specific to the Service, as the case may be, as provided in the Marketplace.

However, in case of Service, if any condition specified in General Terms and Conditions is contradicted by the conditions stipulated in Service Level Agreement specific to said Service, then it will over-ride the conditions in the General Terms and Conditions.
