PART - A (Technical Bid)

1. U.P.S.I.C. was established in the year 1958 as a State Government undertaking to Promote, aid and faster the growth of small scale industries in the State of Uttar Pradesh under the Marketing Assistance Scheme (MAS), Corporation procure orders from Government Departments / Semi Government Organization for the supply of items reserved by the Ministry of Micro Small & Medium Enterprises, Government of India. and the State Government to be purchased from MSME's.
2. The supply order so received are passed on to MSME's registered with UPSIC Ltd. under the Marketing Scheme. In a drive to get the competitive rates of the items reserved for the MSME's to be supplied to the Government Department/ Semi Government Department, item wise rates on enclosed details are invited through this Tender Notice dated 26 May 2026 and the rates will remain valid for one year and if supplying units desire then the validity may be extended at the sole discretion of the Managing Director, UPSIC Ltd. Kanpur.
3. The documents to be furnished with this Technical Bid are as follows, duly attested preferably by the Gazetted Officer or may be self attested :-

 - (b) Last Clearance/Return detail of Income tax.(Copy to be Enclosed)

 - (d) Valid Udyam Certificate of MSME No.(Copy to be Enclosed)
 - (e) **It is must to Each Unit to submit make of components with Tender documents. & Self certification on letter head for accepting all terms and conditions of corporation regarding this work if allotted.**
 - (f) The E-Tender will open for download online on E-procurement website of U.P. Government "**etender.up.nic.in**" up to 12:00 hours **(12.00 PM) on 06 June 2026** and site will be opened for submission online up to 14:00 hours **(02.00 PM) 06 June 2026. Tender will open on same day on 06 June 2026** by the Corporation at 15:30 hours **(3:30 PM) at Area Office U.P. Small Industries Corporation Ltd. 5- B Katra road Prayagraj.** All Tender documents must be submitted in physical form in Envelop from the perspective enterprises participating in the tender will be received before the time of opening of tender along with Tender Cost & Earnest Money at Office of the Area Manager U.P.S.I.C. Ltd. Prayagraj.

- (g) The Tenderers are advised to see the laid down specifications in the notice inviting Tender & to familiarize with all terms & condition of the tender before submitting their rates.
- (h) The successful bidder (MSME Unit), will have to sign the agreement with UPSIC Ltd. Prayagraj within a Week's time. After allotting any order to Unit.
- (i) **Validity of Tender** : Tenders shall remain open for acceptance for the period of 4 Months from the date of opening of tenders.
- (j) Canvassing in connection with the tenders is strictly prohibited and the tender submitted by the tenders, who adhere to canvassing in any way, are liable to be rejected.
- (k) The Corporation will levy nominal service charges of 3% on the value of supplies made by successful MSME, as approved by the Board of Director, as of now.
- (l) 1% Earnest Money of the order value to be deposited with the tender before the tender opening and that will be adjusted against Security Deposit of successful bidder. Earnest Money of the unsuccessful tenderer will be refunded by UPSIC Ltd. after finalization of the tender by the Corporation, as per procedure.

Conditions of Supply & Installation of 251 Nos. 18 watt Solar Street Light in Assembly of Karchana Vikash Khand Chaka District Prayagraj.

- (a) The specifications of the above items will be same as enclosed & mentioned with the tender form, in detail
- (b) The transportation charges, freight, transit insurance, packing loading - unloading etc. will be borne by the unit.
- (c) If there is any loss during transportation, it will be borne by the unit supplying the above items. If the items supplied by the unit are not as per specifications and required quality then units has to replace the same at his cost. If the unit does not replace the bad quality items then this corporation will be compelled to stop the payment to make good the losses if any and unit supplying the items will be black listed, as per procedure.
- (d) If during the supply period there is any dispute between the corporation and the unit the decision of the Managing Director of UPSIC, Kanpur will be acceptable to both party.
- (e) **Warranty** Unit are responsible for repair or replace the supplied Item for the period of 05 years from the date of installation/supply against any defect inform by the Indenting Department.
- (f) In case of any dispute Judicial Jurisdiction will be Hon. court of Prayagraj
- (g) TENDERER will submit all tender documents self attested along with tender form fee & Earnest money deposit in Original before opening of Tender.
- (h) Units shall have annual turnover of minimum Rs. 10.00 Lac (Rs. Ten Lac) in a current financial year or have plant and machinery of worth Rs. 10.00 Lac (Rs. Ten Lac) will only eligible for participating in this tender.

Compensation for Delay:

- (a) The successful tenderer will have to attend the office, of U.P. Small Industries Corporation Ltd., 5-B Katra Road, Prayagraj to sign the contract documents within one week after receiving communication of the acceptance of his tender, otherwise his work order will be cancelled and the Corporation will be free to assign work to other MSME, in the interest of work
- (b) The successful tendered will have to start the work within seven days after the execution of contract bond and has to give adequate proof of start of work failing which, his work order will be cancelled and the unit will be black listed as per laid down procedure of the Corporation and corporation could imposed penalty @ Rs. 1000/- per day after granted period.
- (c) The successful tenderer has to complete the work within stipulated time fixed by the Indenting Department, otherwise supplying unit shall be responsible for any damage /penalty if any imposed by Indenting Department or UPSIC
- (d) Any Two tenderer Should not have any blood relation otherwise both tender will be rejected
