1. All the bidders have to submit EMD of INR mentioned in the catalogue for participation in the e-auction. The successful H1Bidder will have to keep security deposit of 20% of each item or consolidated value of allotted items (Including EMD amount) the same shall be kept hold for the contract duration and security amount (on request of h1 buyer security deposit also be adjusted at the completion of contract)shall be refunded to the Buyer after expiry of the contract. Special Note:

1.
