1. The intending bidder must read the terms and conditions of **CPWD-6** carefully. He should only submit his tender if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of tender document.
3. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from **website** <https://etender.cpwd.gov.in> or www.cpwd.gov.in free of cost.
4. The intending bidder must have valid class-III digital signature **certificate with the encryption key (combo type) to perform any operations / transactions on the e-tendering portal/ website and the bidder should download and install the eMsigner on their system as per instructions available on download section of** <https://etender.cpwd.gov.in>.
7. On opening date, the contractor can login and see the tender opening process. After opening of tenders, he will receive the competitor tender sheets.
8. Contractor can upload documents in the form of JPG format and PDF format.
9. Contractor must ensure to quote rate in the prescribed column (s) meant for quoting rate in figures appears in **Yellow** colour and the moment rate is entered, it turns **sky blue**.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0".

Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).

6. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
7. While submitting the revised bid, contractor can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
8. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.

9. Insurance Surety Bonds/Account Payee Demand Draft/ Fixed Deposit Receipt/Banker's Cheque Bank Guarantee of any Commercial Bank against EMD (drawn in favour of Executive Engineer (E), HCED, CPWD, HAF, HINDAN, GHAZIABAD) shall be scanned and uploaded to the e-Tendering website within the period of bid submission. 10. The bid submitted shall become invalid and e-Tender processing fee shall not be refunded if:

1. The contractor whose bid is accepted will be required to furnish performance guarantee of 5% (Five Percent) of Estimated cost put to tender (ECPT), whichever is higher. A bidders shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. 16. The contractor shall not be permitted to bid for works in the CPWD Circle (Division in case of contractors of Horticulture/Nursery category) responsible for award and execution of contracts, in which his near relative is posted a Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Central Public Works Department or in the Ministry of Urban Development. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
17. No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing.
