- (b) He directly procures the equipment of approved make from manufacturer and get it installed from authorised agency/service provider of the manufacturer or specialized agency as per criteria mentioned in NIT.

6. The bid document consisting on plans, specification, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website <https://etender.cpwd.gov.in> or www.cpwd.gov.in free of cost.

7. But the bid can only be submitted after deposition of original EMD either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CPWD within the period of bid submission and uploading the mandatory scanned documents such as Demand draft or Pay order or Bankers Cheque or Deposit at call Receipt or Fixed Deposit Receipts and Bank Guarantee of any schedule bank towards EMD in favour of Executive Engineer (E), KCED-I, CPWD, Kolkata, receipt for deposition of original EMD to division office of any Executive Engineer (including NIT issuing EE/AE(P)/AAO), CPWD and other documents are specified.
The bidder shall read the document carefully before participate in the bidding process. The EMD/PG shall be given to the department in the name of **Executive Engineer(E), KCED-I .CPWD ,Kolkata** only, otherwise if any Discrepancies as observed at the time of opening of the bid, the offer of the bidders shall be summarily rejected without giving any reason. No post tendering complaint shall be entertained by this office

8. That contractor not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.

9. The intending bidder must have valid class-III digital signature to submit the bid.

10. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor bid sheet.
11. Contractor can upload documents in the form of JPG format and PDF format.
12. Contractor must ensure to quote rate in the column (5) meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as "0". Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0" (ZERO).

The enlistment of the contractors should be valid on the last date of submission of bids. In case the last date of submission of bid is extended, the enlistment of contractor should be valid on the original date of submission of bids.

- 1.1 The work is Estimated Cost Rs. 28,34,059.00. This estimate, however, is given merely as a rough guide.**

- 1.1.1** The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the bids. He will also nominate Division which will deal with all matters relating to the invitation of bids. For composite bid, besides indicating the combined estimate cost put to bid, should clearly indicate the estimate cost of each component separately, the eligibility of bidders will correspond to the combined estimated cost of different components put to bid.

- 1.2** Intending bidders is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:-

To become eligible for issue of bid, the bidders shall have to furnish an affidavit as under:-

I/We undertake and confirm that eligible similar works (s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred to bidding in CPWD in future forever. Also, if such as violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free of forfeit the entire amount of Earnest Money Deposit/ Performance Guarantee. (Scanned copy to be uploaded at the time of submission of bid)



- 1.2.1 Conditions for Non-CPWD registered contractors only, if bids are also open to non-CPWD Contractors. For works estimated cost upto tendering limit of class -I Buildings & Roads (erstwhile Composite/ Building/ infrastructure) category Contractor (However, for Horticulture category, it may be modified as per bidding limit of CPWD class I contractors of Horticulture category). (i) Three similar works each of value not less than Rs.....or two similar works each of value not less than Rs.....or one similar work of value not less than Rs.....(all figures rounded to nearest convenient figure) during the last 7 years ending last day of the month previous to the one in which tenders are invited.
- 1.2.3 When bids are invited from non CPWD contractors and CPWD class II contractors as per provisions of clause 1.2.1 above, it will be mandatory for non CPWD contractors and CPWD class II contractors to upload the works experience certificate (s) and the affidavit as per the provisions of clause 1.2.2.

But for such bids, Class-I contractors of CPWD are eligible to submit the bids without submission of work experience certificate and affidavit. Therefore CPWD class-I contractors shall upload two separate letters for experience certificate and affidavit that these documents are not required to be submitted by them. Uploading of these two letters in mandatory otherwise system will not clear mandatory fields.

2. Agreement shall be drawn with the successful bidders on prescribed Form No. CPWD 7/8 (or other Standard Form as mentioned) which is available as a Govt. of India Publication and also available on website www.cpwd.gov.in. Bidders shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
3. The time allowed for carrying out the work will be 12 (Twelve) Months from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with date phasing, if any, indicated in the bid documents.
4. The site for the work is available.
5. The bid document consisting of plants, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except Standard General Conditions of Contract Form can be seen on website <https://etender.cpwd.gov.in> or www.cpwd.gov.in free of cost.
6. After submission of the bid the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
7. While submitting the revised bid, contractor can revise the rate of one more items (s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.



8. When bids are invited in three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
9. Earnest Money in the form of Demand Draft of Pay Order of Banker's Cheque or Deposit at Call Receipt or Fixe Deposit Receipt drawn in favour of Executive Engineer (E), KCED-I, CPWD, Kolkata shall be scanned and uploaded to the e-Tendering website within the period of bid submission. The original EMD should be deposited either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CPWD within the period of bid submission. A part of earnest money is acceptable in the form of bank guarantee also. 10. The bid submitted shall become invalid and e-Tender processing fee shall not be refunded it:

 - (iii) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest bidder in the office of bid opening authority.

11. The contractor whose bid is accepted will be required to furnish performance guarantee of 5% (Three Percent) of the bid amount within the period specified in Schedule F. This guarantee shall be in the form Banker's cheque of any scheduled bank/Demand Draft of any schedule bank/Pay order or any Schedule Bank of any scheduled bank (in case guarantee amount is less than Rs. 1,00,000/-) or Government Securities or Fixed Deposit Receipts or Guarantee Bonds of any Schedule Bank or the State Bank of India in accordance with the prescribed form. A bidders shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. Submission of a bid by a bidders implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which store, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

13. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
14. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable for rejection.
15. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
16. The contractor shall not be permitted to bid for works in the CPWD circle (Division in case of contractors of Horticulture/Nursery category) responsible for award and execution of contracts, in which his near relative is posted a Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). The shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazette officer in the Central Public Works Department or in the Ministry of Urban Development. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.



- 17 No Engineer of Gazetted Rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as fore said before submission of the bid or engagement in the contractor's service.
18. The bid for the works shall remain open for acceptance for a period of 30 (thirty) days from the date of opening of bids in case of single bid system in case of single bid system.
If any bidders withdraws his bid before the said period or issue of letter of acceptance, whichever is earlier, or makes any modifications in the terms and conditions of the bid which are not acceptable to the department, then the Government shall, without prejudice to any other right or remedy, be at liberty to forfeit 50% of the said earnest money as aforesaid. 23. **Payments Terms: [No ADVANCE payment will be made against supply of items]**
For LED Fittings Part Payment/Final payment will be made on submission of Guarantee Certificate for 5 (five) years from Authorised signatory and
For other items, the part rates will be decided by the Engineer-in-Charge of the work and shall be binding on the contractor.
24. The main contractor shall be responsible for coordinating the activities of all works and will ensure progress of works as per laid down program.
25. The main contractor and / or his associated electrical contractor or his representative is bound to sign the site order books as and when required by the Engineer-in-charge and will comply with the remarks therein.
26. The contractor shall make his own arrangement at his own cost for electrical / general tools and plants required for the work.
27. The connections, interconnections, earthing and loop earthing shall be done by the contractor when ever required to be done for energisation of the installation and nothing extra shall be paid on this account.
28. The contractor must be able to work on concrete slabs / walls as and when required and in complete coordination with the civil works. Cutting of chases in the plastered wall shall in no case be allowed. The contractor shall fix conduits and boxes in the walls soon after the brick work is completed and finish the case to rough surface with proper cement sand mixture. Only in exceptional cases e.g. where cutting of plastered surface can not be avoided it will be contractor's responsibility to ensure that plastering is done to match the original finish at no extra cost.
29. The contractor shall remove all the debris due to the electrical works from the site as soon as the work is completed.
30. The wiring and conduit route shall be marked by the contractor in the drawing first, and shall be got approved from Engineer-in-Charge.
31. Some light points in lobby / corridors / stair case / lift shaft etc are group controlled which will be measured as per specifications.
32. The rupturing capacity of the MCB's shall be 10KA. The MCB's shall have ISI mark. Quantities of MCBs of different rating of 6 amps to 32 amps shall be brought in consultation and after obtaining approval from the Engineer-in-Charge.
33. All the MCCB's shall be rated for Ics=Icu
34. The copper wires to be used on this work shall be FRLS type and ISI marked.
35. The make of switch boxes shall be the same as that of switches. Only the required knockouts of the switch boxes are to be removes for terminating the conduit pipes with PVC glands / check nuts.
Make of MCB / MCCB shall be the same as the make of MCB DB.
All the switch boxes, MCB DBs are to be covered with plastic sheet / petroleum gelly when installed in brick work till the plastering / painting is done to avoid sticking of cement plaster / splashes of the paint. Cement plaster / paint are

to be cleaned immediately after plaster to avoid rusting of switch boxes and MCB DBs. The plastic sheet is to be removed at the time of handing over.

All pin 15 amp and 6 pin 15/16 amps power sockets, fan regulator shall be of 2/3 module type.

36. The electrical works shall be carried out by the contractor, side by side with the progress of the civil works.
37. The contractor shall on demand by the Engineer-in-charge, furnish the proof to the satisfaction of Engineer-in-charge regarding purchases of wires, modular switches & accessories, MCB's MCB DB, fittings, accessories and other items, from the manufacturer's authorization outlets.
38. All PVC conduits accessories shall be of the same make as conduits. The conduits shall be terminated at switch boxes / metallic junction boxes with suitable PVC glands / check nuts.
39. Cutting of brick walls shall be with chase cutting machine only. All repairs and patch works shall be neatly carries out to match the original finish and to the entire satisfaction of the Engineer-in-charge.
40. All the sub main and circuit wiring includes loose wire for connections inside switch boxes and MCB DB's No payment for these wires shall be made. However wires within the cubical panel will be measured and paid under relevant item of work. All the circuit/sub main wiring are to be suitably numbered with stickers/maker pen at LT panel, MCB DB's switch boards (ON backside of cover plate) for ease of maintenance. Nothing shall be paid extra on this account.
41. The contractor shall submit the completion plan separately in triplicate on blue print with one set on tracing "Cloth" as per clause-8 of the contract within 30days of the completion of work. In case, the contractor fails to submit the plan, he shall be liable to pay a sum equivalent to 2.5% of the value of the work subject to a ceiling of Rs. 25, 000.00.
42. To facilitate drawing of wires, 18 SWG GI fish wire shall be provided along with laying of recessed conduit for which no extra payment shall be made. Conduits laid for other services, like fire alarm, PA etc, where wiring is not done along with EI works, fish wire shall be invariably drawn.
43. The connection between incoming switch / isolator and bus bar shall be made with suitable size of thimble and cable at no extra cost.
44. Copper conductor of insulated cables of size 1.5 Sq.mm and above shall be stranded and terminals provided with crimped lugs.
45. All MS junction box cover should be of phenolic laminated / good quality plastic sheet of thickness not less than 3 mm and for which nothing extra shall be paid on the account.
46. All sub-main/power/light wiring shall be terminated in the main board as well as in the switch boards/socket outlets with suitable copper lugs / thimbles for which nothing extra shall be paid on this account.
47. All hardware items such as screw, thimbles, GI wire etc which are essentially required for completing an item as per specifications will be deemed to be included in the item even when the same have not been specifically mentioned.
48. All hardware items such as nuts / bolts / screws / washers etc to be used in work shall be zinc / cadmium plate iron.
49. Any conduit which is not be wired by the contractor shall be provided with GI fish wire for wiring by some other agency subsequently. Nothing extra shall be paid for the same.
50. While laying conduit, suitable size junction boxes shall be provided for pulling the wire as per the decision of the Engineer-in-Charge.
51. Materials to be used in work are to be **ISI marked**. The make of the materials have been indicated in the list of acceptable makes. No other makes will be acceptable. The materials to be used in the work shall be got approved by the Engineer-in-Charge / his representative before use at site. The Engineer-in-charge shall reserve the right to instruct the contractor to remove the materials which, in his opinion, is not acceptable.
52. Where switches / sockets / regulator / telephone / TV / internet outlets are to be provided the same shall be of only one make.
53. While laying conduits for fire alarm system, sufficient junction outlets are to be provided as per the direction of the Engineer-in-charge for detectors as reqd.
54. Wherever light fittings are proposed to be provided on the false ceiling, the respective light / fan point wiring will have to be brought up to the terminal of the light fittings / fans by the contractor. Flexible metal conduits shall be used for drawing wires from ceiling to fittings on false ceiling and nothing extra shall be paid to the contractor for the same.
55. Rate Rationalization shall be applicable in case the same item appears more than once in the schedule of work under the same sub-head or among the different subhead of works. Accordingly the lowest rate quoted for that item among all the sub-heads shall be considered for all similar items for evaluation of tender and making payment.
56. All statutory deductions like GST, labour welfare cess etc. shall be made from the bills.

5. Providing Services for attending Day to day Operation of IEI & Fans ETC. as listed by attending complaint & overall look after.
6. **The staff employed shall have the following experience and qualification for Day to day operation & Maintenance**
 - a) The Skilled Person should have of required category Electrical License / Electrical workman permit / workman's competency certificate / electrical workman's license / lineman license / practically work experienced certificate / Certificate from ITI / CTI or similar reputed institution in the appropriate trade.

28. Some restrictions may be imposed by the security staff etc. on the working and the movement of labour, materials etc. The contractor shall remain bound to follow all such restriction / instructions and nothing extra shall be payable on this account.
29. Unless otherwise provided in the schedule of quantities of the work the rates tendered by the contractor shall be all inclusive and shall apply to all heights, lifts, leads and depths of the building and nothing extra shall be payable to him on this account.
30. The maintenance activities should be carried out, only by personnel competent for the respective type of activities. Only genuine spare parts should be used in replacement of components.
31. All test registers and material at site register shall be maintained by the Contractor which will be reviewed by the Officers of CPWD at regular intervals. These registers shall be issued to the contractor by the Engineer-in-Charge. Contractor shall be responsible for safe custody of all the test registers
32. Log books are to record the reading such as current, voltage, operating periods etc. Maintenance register should indicate actual compliance to the schedule item wise. Major repairs or replacement should be recorded in the History Book.
33. The agency has to be vigilant and attend any break down in the system immediately under intimation to the department.

Both the parties can be paid consequent to the execution as per agreement to the extent this MOU permits. In case of any dispute, either of us will go for mediation by the Engineer In charge. Any of us may appeal against the mediation to the Chief Engineer cum ED, CPWD, Bangalore. His decision shall be final and binding on both of us. We have agreed as under :

- 1. The Associated Contractor will execute all E & M works in the wholesome manner as per terms and conditions of the agreement.*
- 2. The Associated Contractor shall be liable for disciplinary action if he fails to discharge the action(s) and other legal action as per agreement.*
- 3. All the machinery and equipment, tools and tackles required for execution of the E & M works, as per agreement, shall be the responsibility of the Associated Contractor.*
- 4. The site staff required for the E & M work shall be arranged by the Associated Contractor as per terms and conditions of the agreement.*

5. Site order book maintained for the said work shall be signed by the main contractor as well as by the Engineer of the Associated Contractor and by Associated Contractor himself.
6. All the correspondence regarding execution of the E & M work shall be done by the department with the Associated Contractor with a copy to the main contractor. In case of non-compliance of the provisions of agreement, the main contractor, as well as the associated contractor shall be responsible. The action under clauses 2 and 3 shall be initiated and taken against the main contractor in the wholesome manner as per terms and conditions of the agreement.

INTEGRITY AGREEMENT

President of India represented through Executive Engineer (E), Kolkata - II, CPWD, Nizam Palace, Kolkata - 20 (Hereinafter referred as the Principal/Owner', which expression shall unless repugnant to the meaning or context hereof include its successors and permitted assigns)

Preamble

WHEREAS the Principal / Owner has floated the Tender (hereinafter referred to as "Tender/Bid") and intends to award, under laid down organizational procedure, contract.

Here in after referred to as the "Contract".

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s). AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

Article 1: Commitment of the Principal/Owner

1) The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:

(a) No employee of the Principal/Owner, personally or through any of his/her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.

(b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential / additional information through which the Bidder(s) could obtain an advantage in relation to the Tender process or the Contract execution.

(c) The Principal/Owner shall Endeavour to exclude from the Tender process any person, whose conduct in the past has been of biased nature.

2) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

Article 2: Commitment of the Bidder(s)/Contractor(s)

1) It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of fraud or corruption or Coercion or Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.

2) The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:

a) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal/Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.

b) The Bidder(s)/Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.

c) The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/Contract(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal/Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted Electronically.

d) The Bidder(s)/Contractor(s) of foreign origin shall disclose the names and addresses of agents/representatives in India, if any. Similarly, Bidder(s)/Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participates in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.

- e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
- 3) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.
- 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/her reputation or property to influence their participation in the tendering process).

Article 3: Consequences of Breach

Without prejudice to any rights that may be available to the Principal/Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

Contractor shall ensure, such as to not put his reliability or credibility in question, the Principal/Owner after giving 14 day notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.

- 2) Forfeiture of EMD/Performance Guarantee/Security Deposit: If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.
- 3) Criminal Liability: If the Principal/Owner obtains knowledge of conduct of a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal/ Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

Article 4: Previous Transgression

- 1) The Bidder declares that no previous transgressions occurred in the last 5 years with any other Company in any country confirming to the anticorruption approach or with Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.

- 2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Contractor as deemed fit by the Principal/ Owner.
- 3) If the Bidder/Contractor can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.

Article 5: Equal Treatment of all Bidders/Contractors/Subcontractors

- 1) The Bidder(s)/Contractor(s) undertake(s) to demand from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the principles laid down in this agreement/Pact by any of its Subcontractors/ sub-vendors.
- 2) The Principal/Owner will enter into Pacts on identical terms as this one with all Bidders and Contractors.
- 3) The Principal/Owner will disqualify Bidders, who do not submit, the duly signed Pact between the Principal/Owner and the bidder, along with the Tender or violate its provisions at any stage of the Tender process, from the Tender process.

Article 6- Duration of the Pact

This Pact begins when both the parties have legally signed it. It expires for the Contractor/ Vendor 12 months after the completion of work under the contract or till the continuation of defect liability period, whichever is more and for all other bidders, till the Contract has been awarded. If any claim is made/lodged during the time, the same shall be binding and continue to be valid despite the lapse of this Pacts as specified above, unless it is discharged/ determined by the Competent Authority, CPWD.

Article 7- Other Provisions

- 1) This Pact is subject to Indian Law, place of performance and jurisdiction is the Headquarters of the Division of the Principal/Owner, who has floated the Tender.
- 2) Changes and supplements need to be made in writing. Side agreements have not been made.
- 3) If the Contractor is a partnership or a consortium, this Pact must be signed by all the partners or by one or more partner holding power of attorney signed by all partners and consortium members. In case of a Company, the Pact must be signed by a representative duly authorized by board resolution.
- 4) Should one or several provisions of this Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
- 5) It is agreed term and condition that any dispute or difference arising between the parties with regard to the terms of this Integrity Agreement / Pact, any action taken by the Owner/Principal in accordance with this Integrity Agreement/Pact or interpretation thereof shall not be subject to arbitration.

Article 8- LEGAL AND PRIOR RIGHTS

All rights and remedies of the parties hereto shall be in addition to all the other legal rights and remedies belonging to such parties under the Contract and/or law and the same shall be deemed to be cumulative and not alternative to such legal rights and remedies aforesaid. For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the Tender/Contact documents with regard any of the provisions covered under this Integrity Pact.
