

Buyer added bid specific Additional Terms & Conditions: **(AMC OF AC)**

Criteria	Description
Sight Visit	The bidder of his employee should visit Akashvani, BH, Mumbai assess the volume of work and upload the relevant document related to visit, failing which the bid is liable to be rejected.
GST Registration	GST Registration proof should be submitted alongwith the bid.
Shop act Certificate	Bidder should have valid license from Govt. of Maharashtra under Shops and Establishment Act and his shop should be in MMR (Mumbai Metropolitan Region).
Service Conditions	If the services are not satisfied by the bidder, the contract will be terminated within one month notice period.
