Terms & Conditions

1. The quoted rate shall be for a month period excluding the Sunday. Nothing shall be charged for overtime and night stay etc.
2. If for any urgent official work, the vehicle is required on Sunday(s)/Holidays extra will be paid proportionately considering 26 working days in a month.
3. The driver will be contractor's employer. Nothing shall be paid to the driver by the department.
4. Up-to-date road tax, insurance tax and other tax shall be paid by Contractor during contract period . The vehicle shall be insured covering for third party risk and for the theft.
5. Daily Log Book will be maintained by the driver and it will be got signed by officer using the vehicle
6. Extra for cost of fuel (Petrol/Diesel only) @10 KM/Litre shall be paid by the department at actual
7. Rate The vehicle will be run anywhere in the Bihar State.
8. In case of absence of vehicle or driver on any particular day deduction will be made from the monthly rent proportionately considering 26 working days in a month
9. All maintenance charges and accidental charges shall be borne by the agency.
10. The vehicle should be well maintained and in very good running condition.
11. Average run of the vehicle is expected to be 1500 KM in a month. However, for excess/less run no extra shall be charged or any deduction shall be made.
12. The owner of the vehicle will be place the services of vehicle & driver within 7 days of issue of work order otherwise work order will be cancelled unilaterally without any notice etc.
