- 1 Taxi is hired for performing duty at Doordarshan Kendra, Ripsana Bridge, Haridwar by-pass road, Dehradun
- 2 Taxi is hired for Monthly Running basis for 2500 Kilometer (Two Thousand Five Hundred Kilometer per month).
- 3 Taxi is hired for Monthly payment basis without driver and fuel.
- 4 Taxi should be available round o clock in office premises.
- 5 Taxi will be used for official work as per requirement
- 6 03 No Govt. taxi driver is posted at this station for the purpose of driving
- 7 Firm should have minimum Two vehicles registered in their own names with Taxi numbers and Taxi RC shold be 2024 and above
- 8 Eligible firm should not Sub let the Contract, i.e. original bidder should have to Work otherwise contract will be cancel without any notice.
- 9 Firm cannot change the vehicle without permission of this office.
- 10 In case of vehicle off-road due to any reason(s), the replacement must be provided. In case no replacement is provided, the vehicle shall be hired through available means and equivalent charges shall be recovered from the service provider from bill
- 11 Service provider will carried out the routine maintenance of the vehicle as per requirement of Motor vehicle time to time.
- 12 Vehicle should be insured as first party.
- 13 Fuel (Petrol, Mobil, Coolent and Break oil) will be provided by this office
- 14 The hired vehicle may be required to perform outstation journeys for official duties as and when directed by the Department. Toll Tax / Fast Tag/ State tax / MCD etc. incurred during such official outstation travel shall be paid by service provider and reimbursement from the Department on production of original receipts.
