- The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- Information and Instructions for bidders posted on website shall form part of bid document and to be posted on website.
- The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.etender.cpwd.gov.in free of cost.
Bidders are advised to keep visiting the above-mentioned website from time to time (till the deadline for bid submission) for any updates in respect of the tender documents, if any. Failure to do so shall not absolve the applicant of his liabilities to submit the applications complete in all respect including updates thereof, if any. An incomplete application may be liable for rejection.
- Earnest Money in the form of Insurance Surety Bonds, Account Payee Demand Draft or Banker's Cheque or Fixed Deposit Receipt (FDR), or Bank Guarantee including e-Bank Guarantee (for balance amount as prescribed) from any of the Commercial Bank drawn in favor of **Executive Engineer (E), KED, CPWD, Karnal** shall be scanned and uploaded to the e-Tendering website within the period of bid submission. The Original EMD should be deposited either in the office of Executive Engineer inviting bids of division office or any Executive Engineer, CPWD within the period of bid submission. The EMD receiving Executive Engineer (including NIT issuing EE/AE) shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format (enclosed) uploaded by the tender inviting AE in the NIT.

5. But the bid can only be submitted after deposition of original EMD either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CPWD within the period of bid submission and uploading the mandatory scanned documents. The EMD documents shall only be issued from the place in which the office of receiving division office is situated.
6. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.etender.cpwd.gov.in or www.cpwd.gov.in for free of cost.
7. Those contractors, who are not registered or have not updated their profile on the website mentioned above, are required to get registered / update their profile beforehand. The necessary training materials including the videos with step to step process are available on download section of <https://etender.cpwd.gov.in>
8. The intending bidder must have valid Class-III digital signature certificate with encryption key (combo type) to perform any operations / transactions on the e-tendering portal / website and the bidder should download and install the eMSigner on their system as per instructions available on download section of <https://etender.cpwd.gov.in>.
9. On opening date, the contractor can login and see the bid opening proves. After opening of bids, he will receive the competitor bid sheets.
10. Contractor can upload documents in the form of **JPG** format and **PDF** format.
11. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as “0”. Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as “0” (Zero).

However, If a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above/below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.

The quoted rate shall be inclusive of all Taxes, Royalty, Octroi, GST etc. and bonus payable to workers under labour act. No reimbursement shall be made for taxes paid like GST etc. and Bonus payable under relevant Labour Act.

The “Schedule of Quantity” of the bid may contain items of “Credit” for which bidder is required to quote the percentage for this part either “at par” or “above”. If the bidder quotes the percentage “below”, the same shall be considered “at par” and the bid shall be evaluated accordingly.

12. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
13. It is mandatory to fill details / upload scanned copies of all the documents as stipulated in the bid document. If such document is not uploaded his bid will become invalid and processing fee shall not be refunded.
14. If the Contractor is found ineligible after opening of bids, his bid shall become invalid.
15. **As per DG Circular No. DG/Enlist. Rules-2023/10 dated 22.04.2024, the enlisted contractor will not be allowed to participate in tendering process without uploading the certificate of compulsory ERP Training.**
16. If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest Contractor, the bid shall become invalid.
17. The contractor has to follow standard operating procedures and guidelines for construction & maintenance site for covid-19 outbreak issued vide OM No. 2/9/2020-WII/DG/169 dated 05.05.2020 with upto date modification available on CPWD website. It will also form as a part of the agreement.
18. The work is to be executed in the building which is proposed to be a part of re-development plan for Central Vista. This building may be dismantled during currency of the contract. The intending bidders shall note that no claims what so ever on account of foreclosure of the contract shall be paid by the Department.
19. The bidders are advised to inspect and examine the site & its surroundings and satisfy themselves before submitting their tender. A bidder shall be deemed to have full knowledge of the site whether be allowed.
20. The minimum wage of labourers to be paid by contractor shall be the higher of the wage notified by the Govt. of India, Ministry of labour and that notified by the local administration for New Delhi/Delhi State.

"If work is awarded to me, I/We shall obtain GST registration Certificate, as applicable, within one Months from the date of receipt of award letter or before release of any payment by CPWD, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by CPWD or GST department in this regard."

1. The bidder should read all the instructions, terms & conditions, contract clauses, nomenclature of items, specifications etc., contained in the bid document very carefully, before quoting the rates.
2. The bidder should also read the General conditions of contract for CPWD works 2023 (Amended up to date) published by D.G., CPWD, Nirman Bhawan, New Delhi-110011 which will be a part of the Agreement.
3. The bidder shall quote his rates keeping in mind the specifications, terms & conditions, additional and special conditions etc. and nothing shall be payable extra whatsoever unless otherwise specified.

"Provision for Labour Camp": (No.CSQ/C&M/C37(8)/2005/688 dated 07.07.06.)"

4. The bidder shall have to make his own arrangement for housing facilities for staff and labour away from site and shall have to transport the labour to and fro between site and labour camp at his own cost. No labour huts will be allowed to be constructed at the site.

The enlistment of the contractor should be valid on the last date of submission of bids.

In case the last date of submission of bids is extended, the enlistment of contractor should be valid on the original date of submission of bids.

1. The work is estimated to cost for **Repair/ Renovation work for maintaining IAQ condition.** is **Rs. 5,78,000/- only.** This estimate, however, is given merely as a rough guide.
2. Agreement shall be drawn with the successful bidders on prescribed Form No. CPWD-7 (or other Standard Form as mentioned) which is available as a Govt. of India Publication and also available on website www.etender.cpwd.gov.in. Bidders shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
3. The time allowed for carrying out the work will be **02 Months** from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
4. The site for the work is available.
5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except Standard General Conditions of Contract Form can be seen from website www.etender.cpwd.gov.in free of cost.
6. After submission of the bid the contractor can re-submit revised bid any number of times or withdraw it before last date and time of submission of bid as notified. No post-tender modification is allowed by the tenderers except through negotiations, if required. In case, any tenderer does so, the tender will be rejected and the tenderer will be debarred for future tendering in CPWD for two years by the concerned enlisting authority (In case of CPWD enlisted contractor) and by the concerned CE/SE (In case of non-enlisted contractor).
7. While submitting the revised bid, bidder can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
8. When bids are invited in Three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted, then the bid submitted earlier shall become invalid.
9. Earnest Money in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee (for balance amount as prescribed) from any of the Commercial Banks (drawn in favour of **Executive Engineer (E), KED, CPWD, Karnal**) shall be scanned and uploaded on the e-Tendering website within the period of bid submission. The original EMD should be deposited either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CPWD within the period of bid submission. The EMD receiving Executive Engineer (including NIT issuing EE/AE) shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format (enclosed) uploaded by tender inviting EE in the NIT.

A part of earnest money is acceptable in the form of bank guarantee also. In such case, minimum 50% of earnest money or Rs. 20 lac, whichever is less, shall have to be deposited in shape prescribed above, and balance may be deposited in shape of Bank Guarantee of any Commercial bank having validity for a period of 90 days for single bid works and 180 days for two bid system or more from the last date of receipt of bids which is to be scanned and uploaded by the intending bidders.

The earnest money given by all the tenderers except the lowest tenderer shall be refunded immediately after the expiry of stipulated bid validity period or immediately after acceptance of the successful bidder, whichever is earlier. However, in case of two/ three bid system, earnest money deposit of bidders unsuccessful during technical bid evaluation etc. should be returned within 30 days of declaration of result of technical bid evaluation.

Copy of Enlistment Order and certificate of work experience and other documents as specified in the notice inviting e- tender shall be scanned and uploaded on the e-Tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in e- tender notice shall have to be submitted by the lowest bidder within a week physically in the office of tender opening authority. Online bid documents submitted by intending bidders shall be opened only of those bidders, whose original EMD deposited with any division of CPWD and other documents scanned and uploaded are found in order.

The bid submitted shall be opened at **15:30 PM on 14.08.2026**

10. The bid submitted shall become invalid and e-Tender processing fee shall not be refunded if:-
 - (i) The bidder is found ineligible.
 - (ii) The bidder does not upload scanned copies of all the documents stipulated in the Bid Document.
 - (iii) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest bidder in the office of bid opening authority.
 - (iv) If a tenderer does not quote any percentage above/below on the total amount of the tender or any section/sub head in percentage rate tender, then the tender shall be treated as invalid and will not be considered as lowest tenderer.
11. The contractor whose bid is accepted will be required to furnish **performance guarantee of 5% of ECPT (Five Percent)** of the tender amount within the period specified in Schedule F. This guarantee shall be in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt or Bank Guarantee from any of the Commercial Banks in accordance with the prescribed form. In case the contractor fails to deposit the said performance guarantee within the period as indicated in Schedule 'F', including the extended period if any, the Earnest Money deposited by the contractor shall be forfeited automatically without any notice to the contractor. The earnest money deposited along with bid shall be returned after receiving the aforesaid performance guarantee. The contractor whose bid is accepted will also be required to furnish either copy of applicable licenses/ registrations or proof of applying for obtaining labour licenses, registration with EPFO, ESIC and BOCW Welfare Board including Provident Fund Code No. If applicable and also ensure the compliance of aforesaid provisions by the subcontractors, if any engaged by the contractor for the said work within the period specified in Schedule F.

Intending bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidders implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

13. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.

14. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable to rejection.
15. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
16. The contractor shall not be permitted to bid for works in the CPWD Circle (Division in case of contractors of Horticulture/Nursery category) responsible for award and execution of contracts, in which his near relative is posted as Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazetted officer in the Central Public Works Department or in the Ministry of Urban Development. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
17. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the previous permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's service.
18. **The bid for the works shall remain open for acceptance for a period of 30 days from the date of opening of bid in case of single bid system.**
 - (i) If any tenderer withdraws his tender or makes any modification in the terms & conditions of the tender which is not acceptable to the department within 7 days after last date and time (24 hours basis) of submission of bids, then the Government shall without prejudice to any other right or remedy, be at liberty to forfeit 50% of the earnest money absolutely irrespective of letter of acceptance for the work is issued or not.
 - (ii) If any tenderer withdraws his tender or makes any modification in the terms & conditions of the tender which is not acceptable to the department after expiry of 7 days after last date and time (24 hours basis) of submission of bids, then the Government shall without prejudice to any other right or remedy, be at liberty to forfeit 100% of the earnest money absolutely irrespective of letter of acceptance for the work is issued or not.
 - (iii) Withdrawal of the tender, by the tenderer, shall only be made through e-tender portal. Any other method i.e. through letter/ e-mail etc. shall not be considered.
 - (iv) In case of forfeiture of earnest money as prescribed in para (i) and (ii) above, the bidders shall not be allowed to participate in the rebidding process of the same work.
19. This notice inviting Bid shall form a part of the contract document. The successful bidder/ contractor, on acceptance of his bid by the Accepting Authority shall within 15 days from the stipulated date of start of the work, sign the contract consisting of:-
 - (a) The Notice Inviting Bid, all the documents including additional conditions, specifications and drawings, if any, forming part of the bid as uploaded at the time of invitation of bid and the rates quoted online at the time of submission of bid and acceptance thereof together with any correspondence leading thereto.
 - (b) Standard **C.P.W.D. Form 7** or other Standard C.P.W.D. Form as applicable.
20. Integrity Pact: The contractor shall download the Integrity Pact, which is a part of tender documents, affix his signature in the presence of a witness, and upload the same while submitting online bids for all works of estimated cost put to tender equal or more than the threshold value given I Schedule-F. In the event of his failure to sign and upload the Integrity Pact along with other bid documents, his bid shall be rejected.
21. The intending bidders are required to update their profile in CPWD e-tender portal and to upload their bids well in advance of last date of submission of tender. Various IS/ IEC Codes $\Rightarrow$

- 1.3 The tenderer should, in its own interest, visit the site and get familiarized with the site conditions before tendering.
- 1.4 No T & P shall be issued by the Department and nothing extra shall be paid on account of this.
- 1.5 **Type of Contract:** The work to be awarded by this tender shall be treated as indivisible works contract.

2.0 COMMERCIAL CONDITIONS

2.1 Submission and opening of tender

Earnest Money in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee (for balance amount as prescribed) from any of the Commercial Banks (drawn in favour of **Executive Engineer (E), KED, CPWD, Karnal**) shall be scanned and uploaded on the e-Tendering website within the period of bid submission. The original EMD should be deposited either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CPWD within the period of bid submission. The EMD receiving Executive Engineer (including NIT issuing EE/AE) shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format (enclosed) uploaded by tender inviting EE in the NIT.

A part of earnest money is acceptable in the form of bank guarantee also. In such case, minimum 50% of earnest money or Rs. 20 lac, whichever is less, shall have to be deposited in shape prescribed above, and balance may be deposited in shape of Bank Guarantee of any Commercial bank having validity for a period of 90 days for single bid works and 180 days for two bid system or more from the last date of receipt of bids which is to be scanned and uploaded by the intending bidders.

The earnest money given by all the tenderers except the lowest tenderer shall be refunded immediately after the expiry of stipulated bid validity period or immediately after acceptance of the successful bidder, whichever is earlier. However, in case of two/ three bid system, earnest money deposit of bidders unsuccessful during technical bid evaluation etc. should be returned within 30 days of declaration of result of technical bid evaluation.

Copy of Enlistment Order and certificate of work experience and other documents as specified in the notice inviting e- tender shall be scanned and uploaded on the e-Tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in e- tender notice shall have to be submitted by the lowest bidder within a week physically in the office of tender opening authority. Online bid documents submitted by intending bidders shall be opened only of those bidders, whose original EMD deposited with any division of CPWD and other documents scanned and uploaded are found in order.

- 2.2 The tenderer will have to fill up their rates only in the Schedule of Work in the e-tendering put up on the website by the department. Tenders in whom the price bids are given in any other format are liable to be rejected. The abstract of cost will be required to be filled in.
- 2.3 In the tender bid, there shall be no conditions, whatsoever. In case any tenderer mentions any condition including conditional rebates in their price bid the tender shall be rejected forth with.
- A tenderer will also not be allowed to withdraw or modify any condition and/ or rates after the opening of bids.
- 2.4 The department reserves the right to reject any or all the price bids and call for fresh prices/tenders as the case may be without assigning any reason.

3.0 TERMS OF PAYMENTS

The following percentage of contract rates for the various items included in the contract shall be payable against the stage of work shown herein.

Addition: NIL; Correction: Nil; Overwriting: NIL; Deletion: Nil

- 70% of the contract value, of the sub work, on initial inspection and delivery of materials at site, in good condition, on pro-rata basis.
- 20% on completion of installation of the equipment's and accessories pro-rata basis.
- 10% on completion of testing, commissioning and handing over to the department.

3.1 **SECURITY DEPOSIT**

- The security deposit shall be collected by deductions from the running bills of the contractor at the rate mentioned below. The security deposit can also be accepted in cash or in the form of Government Securities, Fixed Deposit Receipts etc.
- A sum @ 2.5% of the gross amount of the bill shall be deducted from each running as well as final bill of the contractor. Such deductions shall be made unless the contractor has deposited the amount of security at the rate mentioned in cash or Government securities or Fixed Deposit Receipts. This is in addition to the performance guarantee that the contractor is required to deposit as per Clause no. 3.2.
- Security deposit can be released against Bank Guarantee issued by a scheduled bank in the specified format for the full value of the security deposit. The Bank Guarantee shall be kept valid till the expiry of the above guarantee/ maintenance period. The security deposit shall be released after successful completion of the twelve months from the date of completion/commissioning or handing over whichever is later.

3.2 **PERFORMANCE GUARANTEE**

The successful tenderer shall submit an irrevocable performance guarantee of 5% of ECPT in addition to other deposits mentioned elsewhere in the contract for his proper performance of the contract agreement within 15 days of issued of letter of acceptance of tender. This guarantee shall be in the form of Demand draft/Pay order or irrevocable bank guarantee bond of any scheduled bank or the State Bank of India in the specified format or in the form of Government security, fixed deposit receipt pledged in favour of Executive Engineer (E), KED, CPWD, Karnal or as specified in the letter of acceptance of tender. The performance guarantee shall be initially valid up to the stipulated date of completion plus 90 days beyond. This bank guarantee shall be kept valid till the recording of completion certificate for the work by the competent authority.

3.3 Income tax, GST, Labour Cess & other statutory deductions etc. shall be made at source as per the prevalent laws of the Govt. Of India and the Govt. of Delhi. The deductions of Security Deposit, Income-Tax etc. shall be done after calculation of the above due payments as per clauses 3.1 to 3.3 and net payment shall be reduced accordingly.

3.4 However, in case of contracts involving maintenance of building and services/ any other work beyond defect liability period, 2.5% of Performance Guarantee shall be retained as Security Deposit. The same shall be returned year wise proportionately. The validity period of Performance Guarantee shall be extended accordingly.

4 **RATES**

The rates quoted by the tenderer, shall be firm and inclusive of all taxes including, GST etc. and all charges for packing forwarding, insurance, freight and delivery, installation, testing, commissioning etc. at site including temporary construction of storage, risks, over head charges, general liabilities/obligations.

5 **COMPLETENESS OF TENDER**

The work is to be executed in the SAI NCoE, Rohtak where the entry is restricted. It shall therefore be mandatory for the contractor to get proper verification of the work force employed for the work. Proper identification documents shall be submitted, as desired, with the engineer-in-charge or its authorized representative.

6 **STORAGE AND CUSTODY OF MATERIALS**

At present no storage facility is available at site that may be used for storage of sundry materials and erection equipments. The contractor has to make its own arrangements. No separate storage accommodation shall be provided by the department. Watch and ward of the stores and their safe custody shall be the responsibility of the contractor till the final taking over of the installation by the department.

7 **CARE OF THE BUILDING AND OTHER STRUCTURES/ INSTALLATIONS**

Care shall be taken by the contractor while handling and installing the various equipment's and components of the work to avoid damage to the building and its surrounding roads, pavements, horticulture work, boundary wall, sewer and water lines etc. He shall be responsible for repairing all damages and restoring the same to their original finish at his cost. He shall also remove at his cost all unwanted and waste materials arising out of the installation from the site of work. All dismantled material received from site shall be returned to the Junior Engineer (E) at his stores at site.

8 **SAFETY CODE & LABOUR REGULATIONS**

In respect of all labour employed directly or indirectly on the work for the performance of contractor's part of the work, the contractor at his own cost will arrange for the safety provisions as per the statutory provision, BIS recommendations, CPWD code, general conditions of contract and instructions issued from time to time. In case of default the Engineer-in-Charge shall be at liberty to make arrangement and provide facilities as aforesaid and recover the cost from the contractor.

9 TOOLS, PLANT AND MACHINERY

The CPWD shall not provide any tools and plant & machinery. The contractor shall provide all tools, plant and machinery required for execution of work. The contractor shall include its cost in appropriate items of work.

10 COMPLETION PERIOD

The completion period indicated in the tender documents is for the entire work of planning, designing, approval of drawings etc., arrangement of materials & equipments, delivery at site including transportation, installation, testing, commissioning and handing over of the entire system to the satisfaction of the Engineer-in-charge.

11 GUARANTEE

The installation will be handed over to the department after necessary testing and commissioning. The equipments or components, or any part thereof, so found defective during guarantee period shall be forthwith rectified/ repaired or replaced free of cost, to the satisfaction of the Engineer-in-Charge. In case it is felt by the department that undue delay is being caused by the contractor in doing this, the same will be got done by the department at the risk and cost of the contractor. The decision of the Engineer-in-charge in this regard shall be final & binding on the contractor.

11.1 The tender shall guarantee among other things, the following:

- (a) Quality, strength and performance of the materials used as per manufacturers standards.
- (b) Safe mechanical and electrical stress on all parts under all specified conditions of operation.

12 POWER SUPPLY

Power supply for carrying out the E&M works shall be provided at one point near the site and further extension of power supply shall be in the scope of contractor.

13 ACCEPTABLE MAKES OF VARIOUS EQUIPMENTS

The acceptable makes of various equipments/components/accessories have been indicated in "List of Approved Makes". The tenderer shall work out the cost of the offer on this basis. Alternate makes are not acceptable. All items for which the makes are not mentioned in the tender shall be got approved from the engineer incharge before procurement as otherwise the same will be rejected outright.

14 EXTENT OF WORK

- 14.1 The work shall be carried out as per relevant CPWD General Specifications for Electrical and Mechanical works amended up to date, I.E. rules in force and as per the directions of Engineer-in- Charge.
- 14.2 No T & P shall be issued by the department.
- 14.3 Free water and power supply shall be supplied to the contractor by department during installation, testing and commissioning period.
- 14.4 The rates quoted shall be inclusive of all Taxes and duties, nothing extra shall be paid on this Account.
- 14.5 All the materials to be used on the work shall be got approved from the Engineer-in-charge before use. The rejected materials should be removed from the site immediately failing which Engineer-in-charge will get it removed at the risk and cost of the contractor.
- 14.6 The watch and ward of the materials issued to the Contractor or installed at site shall be responsibility of the Contractor till the installations on completion are finally handed over to the Department.
- 14.7 Income Tax, GST and Labour Welfare cess will be deducted at prevailing rates from gross amount of contractor bills.
- 14.8 The contractor has to engage his labour as per site conditions. The department shall not entertain anything extra for the idle labour whatsoever.
- 14.9 The department shall not provide any store accommodation for the stores brought by the contractor or issued by the department.
- 14.10 Damage to the building during execution of work shall be made good by the contractor matching with the surrounding surface, otherwise the same shall be got done at the cost of working contractor.
- 14.11 Any damage to the existing fittings shall be replaced by the contractor at his own cost and risk, to the entire satisfaction of the Engineer-in- Charge.
- 14.12 The makes of material will be as per attached list of approved makes against each item of work or as per instructions of Engineer in charge.
- 14.13 Contractor shall be responsible for conduct of staff/workers deployed at site of work.
- 14.14 Bad workmanship in the opinion of Engineer-in-charge shall not be accepted and shall be rectified at contractor's cost to the entire satisfaction of Engineer-in-charge.
- 14.15 If any item is to be different than whatever mentioned in the schedule of work it should specifically be brought out to the notice of dept while quoting for the tender.

- 14.16 The work is to be carried out in building having very strict regulations. The persons engaged on work must have good character antecedents. The contractor should familiarize himself with the process of obtaining entry passes/entry tokens.
- 14.17 No claim for wastage of labour due to non-issuance of entry token/entry passes shall be considered by the Department.
- 14.18 The contractor shall take all precautions for safety of the workman. If any accident/mishap occur, the department shall not be responsible for the same. Consequently any compensation payable shall be at the contractor's cost.
- 14.19 Any malba generated due to dismantling/execution shall be cleared from the site of work immediately without any extra cost failing which same shall be done by the department and suitable recovery shall be made from the bill of the contractor.
- 14.20 The scaffoldings/temporary ladders, working platform etc. shall be arranged by the firm.
- 14.21 All civil works involving false ceiling, drop ceiling, boxing for concealing supply, openings for fixture in wooden partitions, wooden frames for fixing the old fixture etc. shall be opened and closed, as per his requirement, by the contractor within the scope of the contract.
- 14.22 The contractor shall quote their rates after proper inspection of site before quoting the rate.
- 14.23 All the LED fittings shall be guaranteed for a period of 5 years.
- 14.24 50% of the performance guarantee (proportionate to LED fittings amount) shall be refunded to the contractor soon after the completion of the work and recording of the completion certificate.
- 14.25 50% of the performance guarantee (proportionate to LED fittings amount) shall be retained as Security Deposit.
- 14.26 50% of the performance guarantee (proportionate to LED fittings amount) retained as Security Deposit plus 2.5% Security Deposit already deducted from running bills (total 2.5+2.5=5%) shall be refunded year wise proportionately.

15 INSPECTION AND TESTING

- 15.1 All major equipment shall be offered for initial inspection by the engineer-in-charge or officer authorized by him at manufacturer's works in India. The department may or may not inspect the material at its discretion. The contractor will intimate the date of testing of equipment at the manufacturer's works before dispatch. Contractor shall make all arrangements for inspection of material at works. The department reserves the right to get the equipment inspected by third party inspection also. Such inspection shall be of following categories:
 - (a) Inspection of materials/ equipment to be witnessed at the manufacturer's premises/ at its authorized works in India, in accordance with relevant BIS/ Agreement Inspection Procedure.
 - (b) To receive material at site with manufacturer's Routine & Type Test certificates.
 - (c) To inspect material at the authorized dealer's go-down to ensure delivery of genuine material at site.
 - (d) To receive material after physical inspection at site.
- 15.2 Adequate care to ensure that only tested and genuine materials of proper quality are used in work shall be ensured by firm. The firm shall ensure that:
 - (a) Material will be ordered and delivered at site only with the prior approval of the department. The contractor shall, however, be responsible for timely delivery of material.
 - (b) As and when the order is placed for the items, it shall be endorsed to the engineer-in-charge along with details of Agency, model no. and other delivery details.
 - (c) The firm will be required to procure material like all type of accessories etc. directly from the manufacturer's/dealers authorized by the manufacturer's to ensure genuineness & quality. A sample of all items shall, however, be got approved from the engineer-in-charge, before placement of order.
 - (d) Inspection at factory or at go-down in India, as required, shall be arranged by the firm for a mutually agreed date.
 - (e) Delivery of material shall be taken up only with the consent of department, after clearance of the material. Material shall generally be transported under proper insurance to avert any consequent delay due to damage/ loss during transit. Department shall be at liberty to inspect all documents to taxes/ duties clearances, insurance etc. at its own discretion.
 - (f) Department, however, reserves the right to waive inspection in lieu of suitable test certificates, at its discretion.

16 DISPATCH OF MATERIAL

The contractor shall dispatch all the materials to the site in coordination with the execution of the civil work and in consultation with the Engineer-in-Charge so that the materials are not laying at site more than one month in advance of the stage where the materials are to be taken up for the installation.

17 COMPLIANCE WITH REGULATIONS AND INDIAN STANDARDS

- 17.1 All works shall be carried out in accordance with relevant regulation, both statutory and those specified by the Indian Standards related to the works covered by this specification. In particular, the equipment and installation will comply with the following:
 - (i) Factories Act.
 - (ii) Indian Electricity Rules.
 - (iii) B.I.S. & other standards as applicable.
 - (iv) Workmen's compensation Act.

(v) Statutory norms prescribed by local bodies like CEA, Power Supply Co., etc.

18.2 Nothing in this specification shall be construed to relieve the successful tenderer of his responsibility for the design, manufacture and installation of the equipment with all accessories in accordance with currently applicable statutory regulations and safety codes.

18.3 Successful tenderer shall arrange for compliance with statutory provisions of safety regulations and departmental requirements of safety codes in respect of labour employed on the work by the tenderer. Failure to provide such safety requirement would make the tenderer liable for penalty of Rs 5000/- (Rs Five Thousand only) for each default. In addition, the department will be at liberty to make arrangement for the safety requirements at the cost of tenderer and recover the cost thereof from him.

18 INDEMNITY

The successful tenderer shall at all times indemnify the department, consequent on this works contract. The successful tenderer shall be liable, in accordance with the Indian law and regulations for any accident occurring due to any cause and the contractor shall be responsible for any accident or damage incurred or claims arising there from during the period of erection, construction and putting into operation the equipment and ancillary equipment under the supervision of the successful tenderer in so far as the latter is responsible. Though not mandatory under the terms of these documents, the successful tenderer is advised to take insurance including third party insurance for the men and material, as he may be necessary, to cover the risk in his own interest. No extra payment would be made to the successful tenderer on account of the above.

19 ERECTION TOOLS

No tools and tackles either for unloading or for shifting the equipment for erection purposes would be made available by the department. The successful tenderer shall make its own arrangement for all these facilities.

20 COOPERATION WITH OTHER AGENCIES

The successful contractor shall coordinate the work with other contractor(s)/ agencies engaged in the other construction/maintenance of building and its installations, if any, and exchange freely all technical information so as to make the execution of this work/contract smooth. No remuneration should be claimed from the department for such technical cooperation. If any unreasonable hindrance is caused to other agencies and any completed portion of the work has to be dismantled and re-done for want of cooperation and coordination by the tenderer during the course of work, such expenditure incurred will be recovered from the successful tenderer if the restoration work to the original condition or specification of the dismantled portion of the work was not undertaken by the tenderer himself.

The work shall be carried out with least disturbance during shifting & shut down taken in consultation with the client department.

21 MOBILIZATION ADVANCE

Mobilization advance is not admissible as per the "General Conditions of Contract".

22 INSURANCE AND STORAGE

The contractor may get all consignments duly insured upto the destination from warehouse in its own interest and at his cost. The insurance covers may be valid till the equipment is handed over duly installed, tested and commissioned. All defective and deformed material shall be rejected outright.

23 VERIFICATION OF CORRECTNESS OF EQUIPMENT AT DESTINATION

The contractor shall have to produce all the relevant records to certify that the genuine equipments from the manufacturers has been supplied from origin of manufacturer.

24 TRAINING

The scope of works includes the on job technical awareness training of one persons of department at site. Nothing extra shall be payable on this account.

25 INTERPRETING SPECIFICATIONS

In interpreting the specifications, the following order of decreasing importance shall be followed in case of contradictions:

- (a) Schedule of quantities
- (b) Technical specifications
- (c) Drawing (If any)
- (d) Additional conditions of the contract
- (e) General conditions of the contract
- (f) Relevant BIS or other international code in case BIS code is not available

6.
