1. Taxi is hired for performing duty at Akashvani Kendra, Lal Tibba, Mussorie, Dehradun
2. Taxi is hired for Monthly Running basis (10 Hrs x 7 days) for 1200 Kilometer (One Thousand Two Hundred Kilometer per month).
3. The firm must have working experience in Akashawani & Doordarshan.
4. Taxi is hired for Approx. 10 hours duty daily. The firm must be registered with GST.
5. Taxi will be deployed for picking and dropping of shift duty staff and other official work
6. Taxi Driver should have a valid Driving Licence for LMV (Light Motor Vehicle)
 - a. He has to perform Driver's duty also as and when required as per the
 - b. requirement of the office. He is decent and maintain proper dress up
7. Taxi with driver should be available for 10 hours at City Office, Akashvani Kendra, Lal Tibba, Mussorie, Dehradun is duty point.
8. Firm should have minimum Two vehicles registered in their own names with Taxi numbers and Taxi RC Not later than 2024
9. Eligible firm should not Sub let the Contract, i.e. original bidder should have to Work otherwise contract will be cancel without any notice.
10. Firm can not change the vehicle and driver without permission of this office.
11. In case of vehicle off-road due to any reason(s), the replacement must be provided. In case no replacement is provided, the vehicle shall be hired through available means and equivalent charges shall be recovered from the service provider from next month bill.
