1. The firms who fulfill the following requirements shall be eligible to apply. (Joint ventures are not accepted):

(i) The eligibility criteria mentioned as below:

Specialized Firms who have successfully completed similar works on their own name without associating other agency to carry out work and full filling the eligibility condition as mentioned here under **during last 7 years ending last date of month previous to the one in which tenders are invited.**

(a) Three similar works each of value not less than Rs. 6,66,568/- only or two similar works each of value not less than Rs. 9,99,853/- only or one similar work of value not less than Rs. 13,33,137/- only.

**NOTE:** Similar works means **"SITC / Hiring of Stage Lighting & Audio/Video equipments"**. The value of the executed similar works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum, calculated from the last day of month previous to the one in which tenders are invited

- (iii) Should have had Average Annual Financial Turnover of **Rs. 4,99,926/-** during the last three consecutive years ending 31st March 2026 (**Scanned copy of Certificate from CA with Unique Document Identification Number (UDIN) to be uploaded**). The value of annual turnover figures shall be brought to the current value by enhancing the actual turnover figures at simple rate of 7% per annum.
- (iv) Should not have incurred any loss (profit after tax should be positive) in more than two years during the last five years ending 31st March 2026 (**Scanned copy of Certificate from CA with Unique Document Identification Number (UDIN) to be uploaded**)
- (v) Should have a Banker's Certificate from a commercial Bank for **Rs 6,66,568/-** (**Scanned copy of original Banker's certificate to be uploaded**)
- OR
- Net Worth certificate from CA with Unique Document Identification Number (UDIN) of minimum 10% amount (**Rs. 1,66,642/-**) of ECPT (**Scanned copy of original Net Worth certificate to be uploaded**)
2. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
  3. Information and Instructions for bidders posted on website shall form part of bid document and to be posted on website.
  4. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website [www.etender.cpwd.gov.in](http://www.etender.cpwd.gov.in) free of cost.  
Bidders are advised to keep visiting the above-mentioned website from time to time (till the deadline for bid submission) for any updates in respect of the tender documents, if any. Failure to do so shall not absolve the applicant of his liabilities to submit the applications complete in all respect including updates thereof, if any. An incomplete application may be liable for rejection.
  5. Earnest Money in the form of Insurance Surety Bonds, Account Payee Demand Draft or Banker's Cheque or Fixed Deposit Receipt (FDR), or Bank Guarantee including e-Bank Guarantee (for balance amount as prescribed) from any of the Commercial Bank drawn in favor of **Executive Engineer (E), VBED, CPWD, New Delhi** shall be scanned and uploaded to the e-Tendering website within the period of bid submission. The Original EMD should be deposited either in the office of Executive Engineer inviting bids of division office or any Executive Engineer, CPWD within the period of bid submission. The EMD receiving Executive Engineer (including NIT issuing EE/AE) shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format (enclosed) uploaded by the tender inviting EE in the NIT. If the EMD is deposited in Subdivision office then it shall not be considered and tender shall be rejected.
  6. But the bid can only be submitted after deposition of original EMD either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CPWD within the period of bid submission and uploading the mandatory scanned documents. The EMD documents shall only be issued from the place in which the office of receiving division office is situated.
  7. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website [www.etender.cpwd.gov.in](http://www.etender.cpwd.gov.in) or [www.cpwd.gov.in](http://www.cpwd.gov.in) for free of cost.
  8. Those contractors, who are not registered or have not updated their profile on the website mentioned above, are required to get registered / update their profile beforehand. The necessary training materials including the videos with step to step process are available on download section of <https://etender.cpwd.gov.in>
  9. The intending bidder must have valid Class-III digital signature certificate with encryption key (combo type) to perform any operations / transactions on the e-tendering portal / website and the bidder

should download and install the eMsigner on their system as per instructions available on download section of <https://etender.cpwd.gov.in>.

10. On opening date, the contractor can login and see the bid opening proves. After opening of bids, he will receive the competitor bid sheets.
11. Contractor can upload documents in the form of **JPG** format and **PDF** format.
12. Contractor must ensure to quote rate of each item. The column meant for quoting rate in figures appears in pink colour and the moment rate is entered, it turns sky blue.

In addition to this, while selecting any of the cells a warning appears that if any cell is left blank the same shall be treated as “0”. Therefore, if any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as “0” (Zero).

However, If a tenderer quotes nil rates against each item in item rate tender or does not quote any percentage above/below on the total amount of the tender or any section / sub head in percentage rate tender, the tender shall be treated as invalid and will not be considered as lowest tenderer.

The quoted rate shall be inclusive of all Taxes, Royalty, Octroi, GST etc. and bonus payable to workers under labour act. No reimbursement shall be made for taxes paid like GST etc. and Bonus payable under relevant Labour Act.

13. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
14. It is mandatory to fill details / upload scanned copies of all the documents as stipulated in the bid document. If such document is not uploaded his bid will become invalid and processing fee shall not be refunded.
15. If the Contractor is found ineligible after opening of bids, his bid shall become invalid.
16. **As per DG Circular No. DG/Enlist. Rules-2023/10 dated 22.04.2024, the enlisted contractor will not be allowed to participate in tendering process without uploading the certificate of compulsory ERP Training.**
17. If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest Contractor, the bid shall become invalid.
18. The contractor has to follow standard operating procedures and guidelines for construction & maintenance site for covid-19 outbreak issued vide OM No. 2/9/2020-WII/DG/169 dated 05.05.2020 with upto date modification available on CPWD website. It will also form as a part of the agreement.
19. The work is to be executed in the building which is proposed to be a part of re-development plan for Central Vista. This building may be dismantled during currency of the contract. The intending bidders shall note that no claims what so ever on account of foreclosure of the contract shall be paid by the Department.
20. The bidders are advised to inspect and examine the site & its surroundings and satisfy themselves before submitting their tender. A bidder shall be deemed to have full knowledge of the site whether be allowed.
21. The minimum wage of labourers to be paid by contractor shall be the higher of the wage notified by the Govt. of India, Ministry of labour and that notified by the local administration for New Delhi/Delhi State.

The enlistment of the contractor should be valid on the last date of submission of bids.

**In case the last date of submission of bids is extended, the enlistment of contractor should be valid on the original date of submission of bids.**

1. The work is estimated to cost for **Hiring of Audio & Video Equipment etc. for Celebration of 172nd CPWD Annual Day at Vigyan Bhawan** is **Rs. 16,66,421/- only**. This estimate, however, is given merely as a rough guide.
- 1.1 **To become eligible for submission of bids, the bidders/associates shall have to furnish an affidavit as under:-**  
 I/We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I/we shall be debarred for bidding in CPWD in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee. (Scanned copy to be uploaded at the time of submission of bid) **Note: (Affidavit to be furnished on a "Non-Judicial" Stamp Paper Worth Rs. 10/-)**
2. Agreement shall be drawn with the successful bidders on prescribed Form No. CPWD-7 (or other Standard Form as mentioned) which is available as a Govt. of India Publication and also available on website [www.etender.cpwd.gov.in](http://www.etender.cpwd.gov.in). Bidders shall quote his rates as per various terms and conditions of the said form which will form part of the agreement.
3. The time allowed for carrying out the work will be **02 Days** from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the tender documents.
4. The site for the work is available.
5. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents except Standard General Conditions of Contract Form can be seen from website [www.etender.cpwd.gov.in](http://www.etender.cpwd.gov.in) free of cost.
6. After submission of the bid the bidder can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
7. While submitting the revised bid, bidder can revise the rate of one or more item(s) any number of times (he need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
8. When bids are invited in Two/Three stage system and if it is desired to submit revised financial bid then it shall be mandatory to submit revised financial bid. If not submitted, then the bid submitted earlier shall become invalid.
9. Earnest Money in the form of Insurance Surety Bonds, Account Payee Demand Draft, Fixed Deposit Receipt, Banker's Cheque or Bank Guarantee (for balance amount as prescribed) from any of the Commercial Banks (drawn in favour of **Executive Engineer (E), VBED, CPWD, New Delhi**) shall be

scanned and uploaded on the e-Tendering website within the period of bid submission. The original EMD should be deposited either in the office of Executive Engineer inviting bids or division office of any Executive Engineer, CPWD within the period of bid submission. The EMD receiving Executive Engineer (including NIT issuing EE/AE) shall issue a receipt of deposition of earnest money deposit to the bidder in a prescribed format (enclosed) uploaded by tender inviting EE in the NIT.

A part of earnest money is acceptable in the form of bank guarantee also. Copy of Enlistment Order and certificate of work experience and other documents as specified in the notice inviting e- tender shall be scanned and uploaded on the e-Tendering website within the period of bid submission. However, certified copy of all the scanned and uploaded documents as specified in e- tender notice shall have to be submitted by the lowest bidder within a week physically in the office of tender opening authority. Online bid documents submitted by intending bidders shall be opened only of those bidders, whose original EMD deposited with any division of CPWD and other documents scanned and uploaded are found in order.

10. The bid submitted shall become invalid and e-Tender processing fee shall not be refunded if:-
  - (i) The bidder is found ineligible.
  - (ii) The bidder does not upload scanned copies of all the documents stipulated in the Bid Document.
  - (iii) If any discrepancy is noticed between the documents as uploaded at the time of submission of bid and hard copies as submitted physically by the lowest bidder in the office of bid opening authority.
  - (iv) If a tenderer does not quote any percentage above/below on the total amount of the tender or any section/sub head in percentage rate tender, then the tender shall be treated as invalid and will not be considered as lowest tenderer.
11. The contractor whose bid is finally accepted will be required to furnish **performance guarantee of 5% (Five Percent)** of the **Estimated Cost Put to Tender (ECPT) or quoted amount (Whichever is higher) as mentioned in Schedule 'E'** and within the period specified in schedule F. Intending bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids as to the nature of the ground and sub-soil (so far as is



practicable), the form and nature of the site, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions and rates at which stores, tools and plant, etc. will be issued to him by the Government and local conditions and other factors having a bearing on the execution of the work.

13. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
14. Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable to rejection.
15. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.
16. 1. The work shall be carried out as per CPWD specifications for Electrical works amended up to date as applicable, as per actual requirement at site and upto the entire satisfaction of the Engineer in Charge.
2. No T & P shall be issued by the department. All the T&P should be available at site. In case the T&P is not available the department will arrange the T&P and give it to the contractor's staff and will recover the amount from the contractor's bill.
3. "The Vigyan Bhawan, New Delhi is very prestigious building of National importance; all due care and instructions related to this work is to be followed accordingly.
4. During execution of work, necessary care is to be taken for existing installations. The firm and their labourers should aware about guidelines and norms regarding preservation of existing lawns/any Structure in Vigyan Bhawan building. Any loss done to the existing system shall be made good on the risk & cost of the firm.
5. The work is to be carried out at very sensitive & highly prestigious site. Hence, the quality of work done and competence of the staff deployed should be in accordance with the exalted/ high status of the site.
6. The site is security bound area where entry passes may be required to be issued. The contractor shall have to follow all the prevailing security practices while working in the premises. Nothing extra shall be paid on account of labour wastage, as the work will be done in VVIP area.
