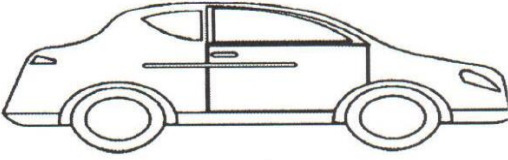

5) Goods and Service Tax (GST): bidder should Submit GST registration No.

6) Driving license:

- Driver of vehicle shall have valid driving license for transporting Passenger vehicle. (I.e- if vehicle gross weight less than 7500KG required LMV (T) ,LMV or PSV Endo, HTV,HMV,HPV driving license).If Driving license not as mention type then change driving license before Starting work.
- Age of Driver Should not be more than 55 Year.
- Two Drivers required for 24-hour vehicle

7) Diesel/Petrol Rate copy:

- Bidder must quote fuel prices on the basis of rates prevailing up to 15 Days before the due date of tender opening.
- If contractor submit diesel/petrol rate copy before date of tender publishing than department will take the rate 15 days before the tender opening.
- If Contractor Has Submitted diesel/Petrol rate copy in witch rates are mention for more than one day, then department will take rate prevailing on 15 days before than due date of Opening tender.

Note:

For participation in tender, the ownership of vehicle is not necessary. Contractor can provide third party's vehicle. In such case, bidder shall have to execute the agreement binding that the whole responsibility about any risks shall pertain to him & not to third party. **The format of same is attached herewith.** The provided third party vehicle shall be same throughout the contract period. In special case, only one time change of vehicle shall be allowed, meeting all the terms of contract & on taking prior approval of competent authority

SPECIAL TERMS AND CONDITIONS:

The terms and condition of this section will be read in conjunction with general terms and condition of tender. However, wherever, ambiguity observed, terms and condition mentioned under Special Terms and Condition will supersede the General Terms and Condition of tender.

- 1) Tenders are invited for hiring of with A/C closed body diesel /Petrol driven, for 24 Hours/day on ARC basis and head quarter at Executive Engineer AM at JAMLA AM Division
- 2) The vehicle to be offered for hiring shall be in up-to-date condition including the tubes, tires, engine as well as condition of outside body. **The vehicle to be offered shall not have been registered before 3 Year as on date of tender opening (RTO registration Date).** However, in case of a very poor response or to break off the likely cartel, a relaxation can be granted for one year with the permission of Circle head. However, the Officers placing an order should ensure that condition of such vehicle is tiptop.
- 3) The touring journey covers the area within Gujarat State and as per the instructions of the Officer.
Agency Finalized under ARC has to carry out work in to nearby circle in case of emergency"
- 4) The rates quoted shall be on **ANNUAL RATE CONTRACT** basis. Thus, rates quoted shall remain valid for complete period of order. The rates must be inclusive of the salary of driver, cost of fuel, oil and other consumables, wear & tear of tyres & tubes and maintenance charges including material cost to keep the vehicle in full working and smooth condition.
- 5) **PERIOD OF CONTRACT: The period of contract is 24 Months. However, contract may be extended further for 12 months on mutual agreement as per same rate, terms and conditions for maximum two times i.e.: Total extension given of two years in two segment of one year each, if required. However, in case of Poor service provided by the contractor, Circle head shall be empowered to terminate the contract after one year of commencement of contract.**
- 6) The GETCO reserves the right to terminate the contract at any time without assigning any reason by giving 15 days' notice in writing. The contractor shall not be entitled to any compensation by reason of such termination of contract.
- 7) The contractor will have to fulfill the condition of contract labour regulation abolition Act-1970 and furnish the records failing which payment will not be made.
- 8) The company will give advance intimation for requirement of vehicle in emergency and during odd hours, however the contractor shall move to provide the vehicle within half an hour of intimation of failing which vehicle shall be hired from market and difference in expenditure will be recovered from the contractor.
- 9) The driver of vehicle shall be well dressed and behaved with manners and respect their officer/staff of the GETCO. Driver shall be well experienced with valid License.
- 10) No advance for hiring of vehicle shall be paid. The bill in triplicate should be forwarded to concerned Engineer and payment will be through **RTGS** within **30 days** after submitting invoice.
- 11) Challan for opening & closing kilometer Readings & Kilometers travelled should be got certified & duly signed by the officers travelling the vehicle. In absence of the above requirement the bill will not be paid.
- 12) It is the whole and sole responsibility of vehicle owner during accident to pay compensation or damages to the persons involved as per law or act.
- 13) If service of the contractor found un-satisfactory, GETCO shall exercise its discretionary power to cancel the order in accordance with the rules.

- 14) If contractor fails to execute the order successfully, the order will be got completed by other agency and if required to pay higher rate in that case difference of rate will be recovered from the contractor including 15% supervision charges + GST.
- 15) The vehicle should be up to date and Petrol/Diesel driven. **Bidder should be given vehicle as per quoted documents in tender. SE TR Himatnagar will be final Authority for any change in vehicle type.**
- 16) For 12/24 hours vehicle weekly one-day W/off available.
- 17) The driver should be fully instructed for the good behavior and to drive the vehicle only in accordance to the clear directive of office-in-charge. In case of driving found rough, contractor shall have to replace the driver with good one.
- 18) In case of any dispute or any discrepancy, the decision of S.E. (TR) Himatnagar will be final and binding to the contractor.
- 19) During the journey, all the RTO rules and regulations should be followed scrupulously and contractor will be responsible for any repercussion arises for non-observance of RTO rules.
- 20) If contractor fails to provide the vehicle on any day as per contract, the deduction from his RA bill should be made on prorata considering the monthly rate payable + GST within 26 days per month.
- 21) Agreement: - As per GETCO's rules contractor will have to enter into an agreement on stamp paper of Rs.300/- with the GETCO in prescribed format before execution of work. The cost of stamp fees shall be borne by the contractor.
- 22) The contractor will have to execute an safety cum indemnity bond, Contract Agreement on stamp paper of **Rs.300/-** at his cost before commencement of order stating that for any accidents or damaged to the contractor's staff/equipment or any other persons/vehicle due to non-observance of safety GETCO will not be responsible.
- 23) Contract will start from the date of receipt of order and the contract will remain for **24** calendar months.
- 24) The S.E. (TR) Himatnagar reserves the right to reject any or all the tenders without assigning any reason thereof.
- 25) Vehicle supplied should be fully insured. Xerox copy of insurance policy should be submitted to this office before placement of order. Insurance for driver should also be arranged by the contractor and Xerox copy should be submitted to this office. All RTO expenses if arises will be borne by the contractor.
- 26) This security deposit is for the performance of contract and the same is liable to be forfeited by the GETCO in event of non-fulfillment of the term and conditions of this contract or cancellation of contract by the contractor. The contractor has to give 03 months' notice period in case of cancellation of contract.
- 27) The bid guarantee/EMD may be forfeited.
- a) If a Bidder withdraws its bid during the period of bid validity specified by the bidder in bid form
- b) If a bidder refuses to accept the contract or fails to commence the works (within fifteen days of letter of award of contract)
- 28) Overtime/Night Hold: If the vehicle is released or used at or after 01.00AM (Midnight), It will be considered as night halt and paid accordingly and overtime charges will not be payable. Over time will be given if vehicle is used for more than hours specified in the tender (i.e.-wherever applicable). The in charge of the vehicle has to manage the vehicle effectively and extra hours' charges will be paid on the basis of the log book copy of actual usage of vehicle only if the actual usage and journey exceeds the hours specified in the tender. Actual Usage of the vehicle is the prime condition to grant Overtime charges.
- 29) The vehicle should have good upholstery covered with clean covers, comfortable seating arrangement and shall be washed/service at regular intervals of a week. Vehicle shall always be kept neat and clean.
- 30) **Penalty: If the contractor fails to provide a vehicle on any day, as per contract penalty of Rs-2000/- per day per vehicle will be recovered from the current and also vehicle will be hired from other agency and if required by paying higher rate , in that case , difference of rates will be recovered from the contractor.**

31) If the contractor fails to provide a vehicle, the deduction from his RA Bill should be made on prorate considering the monthly rate payable within the 26 day per month.

- 32) The toll taxes to be paid during official travelling of vehicle shall be reimbursed to the contractor on production of receipt duly signed by GETCO authority who have travelled or directed a travel. All road tolls / bridge tolls shall be reimbursed on production of proof of payment along with monthly RA bills.
- 33) Hired vehicle shall be fitted with airbag for the person occupying the front seat, other than driver
- 34) In case of accident to the vehicle, it is the responsibility of the driver or occupants of the vehicle. The whole and sole responsibility of vehicle owner/ the contractor for accident to pay compensation or damages to the persons, involved as per law or Act and the GETCO will not be responsible for any claim on this account.
- 35) In case of poor service provided by the contractor, circle head is empowered to terminate the contract as per GETCO terms & condition.
- 36) In case of any dispute or any discrepancy, the decision of Supt. Engineer, Transmission Circle, Himatnagar will be final and binding to the contractor.
- 37) If contractor fails to execute the order successfully, the order will be got completed through other agency and if required to pay higher rate in that case difference of rate will be recovered from the contractor.
- 38) Head Quarter of vehicle will be at Executive Engineer Testing at 220kv AGIYOL Sub Station Under AGIYOL AM Division and journey kilometers will be considered from Head Quarters to Head Quarters & as per Schedule-B.& it will change as per requirement of GETCO & you have to accept as per instruction of order placing authority.
- 39) Contractor will start hiring services from the date of commencement letter of order and the contract will remain valid as per terms and conditions.
- 40) Formula for considering price variation: No price variation will be payable on cost of oil/tyres, tubes etc. Only changes in price of diesel / petrol will be adjustable. For every one-rupee rise/fall in the price of Diesel / petrol per liter, following adjustment will be given.

Diesel/Petrol driven vehicle – 10 paisa (increase / decrease in rate) per Kilometer or any fraction. Thereof for Kilometers traveled by the vehicle after the date of increase / decrease in Diesel/Petrol Price will be paid/Recovered for the actual Kilometers Traveled thereafter.

- 43) The 'Earnest Money Deposit' paid herewith should be absolutely forfeited by the GETCO if the full amount of specified security deposit is not paid in specified time by the successful bidder **SECURITY DEPOSIT:** The 5 % of tender value is required to be paid by Demand Draft/BG in favor of "**Gujarat Energy Transmission Corporation Limited**" Payable at Himmatnagar on acceptance of tender as security deposit **at Circle office-Himmatnagar &** The Security Deposit will be paid within 30 days of receipt of LOI Bidder may be disqualified from participation in future tender if SD is not paid within given time. It the discretion of GETCO part and communication will be entertain in this regards.
- 44) The Supt. Engineer (TR) Himatnagar reserves the right to reject any or all the tenders without assigning any reasons thereof.

- 45) Vehicle supplied should be comprehensively insured. Attested copy of insurance policy should be submitted to this office before placement of order. Insurance for driver should also be arranged by the contractor and attested copy of the same should be submitted to this office.
- 46) The successful tenderer will have to provide full details such as phone No / Mobile/phone No. / Full address Name of responsible person etc for contacting him at any time. Any offer not fulfilling this requirement will be out right rejected
- 47) GEB (i.e. Gujarat Electricity Board) & GETCO (i.e. Gujarat Energy Transmission Corporation Limited.) are interchangeable wherever/ whenever context admits.
- 48) Vehicle will have to be sent along with well-experienced, well-dressed driver having good manners with necessary tools and tackles to meet the normal breakdown while on road. The driver sent with the vehicle shall have valid license for driving and Taxi badge. The driver shall be well versed with R.T.O. rules. **The driver shall be preferably below the age of 40 Year and not more than 55 years.** The lodging and boarding of driver shall be borne by contractor.
- 49) No tools, tackles and manpower for execution of order will be provided by GETCO.
- 50) The driver should be provided with enough money to cover the cost of diesel, repairs and incidental expenditure while in journey.
- 51) The driver should be fully instructed for the Good behavior and to drive the vehicle only in accordance to the clear directives of Officer in charge and as per RTO rules. In case, if driving is found rough, contractor shall have to change the driver with genuine one.
- 52) The contractor shall be indemnify company's personal against any claim arising out of accident or misbehavior of the drivers. The vehicle shall be kept properly insured all the time to cover the 3rd party risk and simultaneously immunize company on account of likely claims from public, police dept etc.
- 53) The general use of vehicle is for line maintenance work to transport man & material, used on Kaccha/Pakka road/Bullock cart way where vehicle approach is possible.

- 56) Conditional tender will not be accepted and straight away be rejected.
- 57) The contractor is bound to furnish his rate justification in the form of rate analysis, if asked.
- 58) The contractor bidding for the work must have vehicle registered in his name or on his firm's name. Failing to produce such proof EMD / SD paid by the contractor shall be forfeited.
- 59) Full size carrier should be provided on vehicle, if required or as per EIC Instructions.
- 60) Rates for excess Kms travelled by hired vehicle, beyond 3000 km /month is admissible occasionally, with written permission of Circle head.
- 61) Any excess travel of vehicle beyond 3000 Kms by the officer in-charge of the vehicle shall be under the written/verbal approval of circle head and the same shall be regularized by an office note giving clear reasons for the travelling beyond stipulated Kms.
- 62) It is advised to mention here that all parties to fill up advance stamp receipt along with RTGS / NEFT of EMD so that in case of party except L1, EMD can be released promptly on receipt of request letter from the party.

- 51) Any bid received by the Owner after the time and date fixed or extended for submission of bids prescribed by the Owner, will be rejected and not considered for evaluation and same will be return as seal condition.
- 52) No Copy of Technical / PRICE-BID requires in Physical copy of bid. It is compulsory to submit Technical / price-bid through on-line (n-code) only.

- 55) Amendment of bidding document.
- At any time prior to the deadline for submission of Bids the Owner may, for any reason, whether at his own initiative or in response to a clarification requested by the intending Bidder, modify the Bidding Document with amendment(s).
 - The amendment will be notified in web site to all intending Bidders who have received the Bidding Document at the address contained in the letter of request for issue of bidding document from the Bidders. Owner will bear no responsibility or liability arising out of non-receipt of the same in time or otherwise.
 - In order to afford prospective bidders reasonable time in which to take the amendment into account in preparing their bids, the Owner may, at his discretion, extend the deadline for the submission of bids.
 - Such amendments, clarifications etc. shall be binding on bidders and will be given due consideration by the Bidders while they submit their bids and shall invariably enclose such documents as a part of the bid
- 56) No bid may be withdrawn in the interval between the deadline for submission of bids and the expiration of the period of bid validity specified by the Bidder on the Bid Form. Withdrawal/modification of a bid during this interval may result in the Bidder's forfeiture of its bid security.
- 57) The Owner will open the technical bids On Line Only, in the presence of Bidder's representatives who choose to attend on the date and time mentioned for opening of bids in the Invitation to Bid or in case any extension has been given thereto, on the extended bid opening date and time notified to all the Bidders who have purchased the bidding document. The Bidder's representatives who are present shall sign a register evidencing their attendance.
- 58) The price bids of all the "Techno-Commercial" Responsive Bidders shall be opened On Line in the presence of representatives (up to two per firm) of such bidders who choose to be present. The date & time of opening the Price Bid shall be intimated to all such qualified bidders by Fax/Telex, at least one week in advance besides inviting final price bid if found appropriate after evaluation of Technical bids.

- 59) No electronic recording/transmitting devices will be permitted during Bid opening.
- 60) The Bids received/accepted/opened will be evaluated by the Owner to ascertain the technical responsiveness of the bid for the complete scope of the proposal, as covered under these specifications and documents. All technically responsive bids shall then be examined to determine the LOWEST EVALUATED COMMERCIALY AND TECHNICALLY RESPONSIVE BIDS.
- 61) To assist in the examination evaluation and comparison of Bids the owner may on his own ask the Bidder for a clarification of its bid and demanding document. The request for clarification and the response shall be in writing and no change in the price or substance of the bid shall be sought, offered or permitted.
- 62) In Price bid bidder are found same rate then circle office invited revise seal price bid of those bidder whose rate are same. Lowest rate bidder are entitle for contract.
- 63) The contractor quoting for the tender is deemed to have gone through General Terms & Conditions of this work / Contract booklet / Special conditions and same will be treated as binding on him
- 64) The contractor has to give his letter for below or above for the total amount indicated against item no. 1 only. The rate against item no. 2 of the schedule is unilaterally decided by GETCO and shall not under go any change. However, the item no 2 shall be subject to variation as per relevant clause of general specification (i.e. variation in diesel /Petrol price.)
- 65) Statutory Variations:
Any statutory increase or decrease in the taxes and duties including GST and Cess as applicable or in the event of introduction of new tax/cess or cessation of existing tax/cess subsequent to suppliers offer if it takes place within the original contractual delivery date will be to COMPANY's account subject to the claim being supported by documentary evidence. However, if any decrease takes place after the contractual delivery date, the advantage will have to be passed on to COMPANY.
- 67) GST
- Every bidder shall inform their GSTIN No. of the registered place(s) where from the bidder intends to supply the goods / services, meaning thereby the bidder has to supply the goods / services from the relevant declared / registered place
- i. Contractor has to submit the GST Registration certificate
- ii. Contractor has to submit invoice/Challan as documentary proof with each RA bill & Final Bill and in which it shall be specifically mention the nature of service & code SAC code under which the amount of service tax GST payable by contractor and payable by GETCO (if any))without fail.
- iii. GETCO will withheld the GST amount of contractor and it shall be reimbursed on production of documents evidences of payment made by contractor
- iv. The Contractor has to submit invoice to GETCO indicating following.
- Name, address and GST registration no. of the service provider
 - Name and address of person receiving the service i.e.GETCO
 - Description and value of taxable service provided
 - The total GST payable thereon with bifurcation of GST payable by service provider and service receiver.
 - Rate and amount of taxes i.e. CGST/ SGST/ IGST/UGST

- Place of supply along with the name of State, in case of a supply in the course of inter-State trade or commerce i.e. Out of Gujarat Supply
- Applicable SAC Code

Contractor has to also supply tax invoice as described under GST rules and Regulation indicating

GSTIN

- v. Contractor has to provide Tax invoice in a standard format as per CGST act, CGST rules 2017 and GST invoicing rules containing all details as provided in Act and rules. Contractor / Supplier has to mention GST no. of GETCO i.e. 24AABCG4029R2ZC in the invoice invariably & failure of which payment will not be made.

Supplier/Contractor should charge GST in Invoice at the rate as agreed to / mentioned in acceptance of tender only and any deviation in the same shall not be accepted. Further, any additional liability of GST (later on due to wrong mentioning of GST rate, mis-interpretation of HSN/SAC Code, etc.) over and above as charged in the invoice shall be borne by the Supplier/Contractor. However, any refund received by the supplier / contractor on account of GST charged from the company; such refund shall have to be passed on to the company, along with interest if any. GENERAL CONDITIONS OF CONTRACT

- 1) The contractor shall be required to supply diesel / Petrol driven closed body vehicle Car having Taxi / Maxi passing from RTO of the models not before Three years as on the date of tender opening and strictly in accordance with the specification laid down in the tender papers. Any vehicle not confirming to the said specifications shall not be accepted.
- 2) The vehicles intended to be placed for hiring must have the following documents completed in all respects and produced to Engineer In charge for verifying:
 - 2.1. Insurance certificate covering period up-to-date.
 - 2.2. Registration certificate book with tax paid up-to-date.
 - 2.3. Any other documents relevant relating to hiring of vehicle.
 - 2.4. Registration as "TAXI" or "MAXI".
- 3) The contractor shall make his own arrangements for the Boarding and lodging of his drivers, agents and servants.
- 4) The vehicles when in service shall have to be parked at the GETCO's premises or as near as the work site is possible.
- 5) The contractor shall ensure that representative on his behalf is deputed by him to keep in touch with the Engineer with regard to detailing of vehicles, providing arrangements for substitutes in case of any vehicles going off road looking after to general need of vehicle.
- 6) The contractor shall also make his own arrangements for refueling, repairs and maintenance of his vehicle and provide other vehicle during maintenance or repair period with all above-mentioned conditions.
- 7) The contractor must follow all the rules, regulations and enactments of the labour laws relating to engagements of persons by him.
- 8) The vehicle once inspected and approved by the Engineer for hire shall not be changed or substituted by the contractor except on orders from the Engineer or on becoming defective/off road due to accident, breakdown, etc. In such an event, the contractor shall give immediate intimation to the Engineer. Where a change of vehicle is likely to last for more than one-week prior approval of this Engineer shall have to be taken.
- 9) The speedometers of the vehicles must be maintained with full accuracy and in working condition/order at all times. Any defect noticed therein must be rectified at the earliest in a period not exceeding two days. Till such time, the meter starts working; the KMs. of journeys for various places shall be decided by the users/ Engineers. Sign and Seal of Bidder Superintending Engineer, Himatnagar.
- 10) No interest shall be paid by the GETCO on Security deposit.
- 11) Tender fee paid for purpose of tender papers is non-refundable.
- 12) The security deposit shall be refunded to successful bidder only after satisfactory completion of the contract or on its termination by the GETCO. The GETCO reserves the right to recover any dues, outstanding against the contractors, from the Security Deposit or towards any loss caused to the GETCO owing to negligence or default of the contractor, his servants or agents. 17) Providing FASTTAG Facility:

- a. Contractor has to submit the statement with monthly RA bill for reimburse the FASTTAG Expenditure.
- b. Keep the minimum balance in FASTAG Account as per rules and recharge regularly to avoid penalty or stacking up in queue.

If due to not maintaining minimum balance or any other reason if the penalty is collected by toll booth, then only basic amount of toll-fee shall be reimbursed. Penalty/Higher rate amount is the responsibility of contractor.

- 18) The contractor shall immunize company's personnel against any claim arising out of accidents or misbehavior of the drivers. The vehicle shall be kept properly insured all the time to cover the 3rd party risk and Simultaneously immunized company on account of likely claims from public, police Dept. Etc.
- 19) The Drivers should be provided with enough money to cover the cost of Petrol/Diesel, repairs, road toll tax / bridge toll tax and incidental expenditure while in journey. Driver should provide mobile phone facility for communication. Driver should always keep all documents relating to vehicle such as R.C.Books, insurance, valid license and PUC certificate or any other important documents in original copy with vehicle.
- 20) Contractor should appoint a driver with valid license according to vehicle. Driver must not be addicted of any habits. Changing of driver shall be intimated by contractor to concern user of vehicle in prior.
- 21) If you fail to execute the order successfully, the order will be got completed through other agency and if required to pay higher rates, in that case difference of rates will be recovered from you.
- 22) Driver shall be preferably with mobile phone facility and mobile charger in vehicle.
- 23) For participation in tender, the ownership of vehicle is not necessary. Contractor can provide third party's vehicle. In such case, bidder shall have to execute the agreement binding that the whole responsibility about any risks shall pertain to him & not to third party. **The Format of same is attached herewith.** The provided third party vehicle shall be same throughout the contract period. In special case, only one time change of vehicle shall be allowed, meeting all the terms of contract & on taking prior approval of competent authority.
