2. The firms/ contractors who fulfill the following requirements shall be eligible to participate in the tender. Joint Ventures are not accepted.
3. The intending bidder must read the terms and conditions of CPWD-6 carefully. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
4. Information and Instructions for bidders posted on the website shall form part of bid document.
5. The bid document consisting of specifications and the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.etender.cpwd.gov.in or <https://cpwd.gov.in> free of cost.

7. 11. The intending bidder must have a valid class-III digital signature to submit the bid.
12. On the opening date, the contractor can login and see the bid opening process. After opening of bids, he will receive the competitor bid sheets.
13. Contractors can upload documents in the form of JPG format and PDF format.
14. Contractor must ensure to quote the percentage above/below /at par. Therefore, if the cell percentage is left blank, the amount shall be computed as "0" (ZERO). Bidder has to take care of this point. The rates quoted by the tenderer shall be firm and inclusive of all the prevailing taxes and GST etc.

15. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
16. If any information furnished by the applicant is found incorrect at a later stage, he shall be liable to be debarred from tendering/taking up of works in CPWD. The department reserves the right to verify the particulars furnished by the applicant independently.
17. The prospective bidder shall use all information relating to the Tender, which is obtained, whether in writing, pictorially form in connection with the Tender and other commercial information of a confidential nature exclusively for the purpose of Tender and not for any other purposes.

The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the bids. He will also nominate Division which will deal all matters relating to the invitation of bids.

13. The competent authority on behalf of the President of India does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidders shall be summarily rejected.
14. Canvassing, whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable to be rejected.
15. The competent authority on behalf of President of India reserves to himself the right of accepting the whole or any part of the bid and the bidders shall be bound to perform the same at the rate quoted.

16. The contractor shall not be permitted to bid for works in the CPWD Circle (Division in case of contractors of Horticulture / Nursery category) responsible for award and execution of contracts, in which his near relative is posted a Divisional Accountant or as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazette officer in the Central Public Works Department or in the Ministry of Urban Development. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
17. No Engineer of Gazetted rank or other Gazetted Officer employed in Engineering or Administrative duties in an Engineering Department of the Government of India is allowed to work as a contractor for a period of one year after his retirement from Government service, without the prior permission of the Government of India in writing. This contract is liable to be cancelled if either the contractor or any of his Employees is found any time to be such a person who had not obtained the permission of the Government of India as aforesaid before submission of the bid or engagement in the contractor's service.
18. The bid for the works shall remain open for acceptance for a period of **06 Months** from the date of opening of bid.

Further

- i) If any tenderer withdraws his tender or makes any modification in the terms & conditions of the tender which is not acceptable to the department within the validity period of tender or
- ii) If after the award of work, the tenderer fails to sign the contract or to submit the Performance Guarantee before the deadline defined in the tender documents

The tenderer shall be suspended for one year and shall not be eligible to bid for CPWD tenders from date of issue of suspension order.

AND WHEREAS the Principal/ Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/ transparency in its relationship with its Bidder(s) and Contractor(s).

ANDWHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as “Integrity Pact” or “Pact”), the terms and conditions of which shall also be read as integral part and parcel of the Tender/ Bid documents and Contract between the parties.

NOW, therefore, in consideration of mutual covenants contained in this Pact, the parties here by agree as follows and this Pact witnesses as under:

Article1: Commitment of the Principal/Owner

- 1) The Principal / Owner commits itself to take all measures necessary to Prevent corruption and to observe the following principles:
 - (a) No employee of the Principal/Owner, personally or through any of his/ her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.
 - (b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in, before and during the Tender process, provide to all Bidder(s) the same information and will not provide to any Bidder(s) confidential/ additional information through which the Bidder(s) could obtain an advantage in relation to the Tender processor the Contract execution.
 - (c) The Principal/Owner shall endeavor to exclude from the Tender process any person whose conduct in the past has been of biased nature.
- 2) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/ Prevention of Corruption Act, 1988 (PC Act) or is in violation of the principles here in mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

Article2: Commitment of the Bidder(s)/ Contractor(s)

- 1) It is required that each Bidder/ Contractor (including their respective officers, employees and agents) adhere to the high esthetical standards, and report to the Government/ Department all suspected acts of fraud or corruption or Coercion or Collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/ Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:

 - b) The Bidder(s)/ Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process. Competitiveness or to cartelize in the bidding process.

- c) The Bidder(s)/ Contractor(s) will not commit any offence under the relevant IPC/PC Act. Further the Bidder(s)/ Contractor(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal / Owner as part of the business relationship, regarding plans, technical proposals, and business details, including information contained or transmitted electronically.
- d) The Bidder(s)/ Contractor(s) of foreign origin shall disclose the names and addresses of agents/ representatives in India, if any. Similarly, Bidder(s)/ Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/ representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participates in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/ parallel tender for the same item.
- e) The Bidder(s)/ Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.

- 4) The Bidder(s)/ Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practice means a willful misrepresentation or omission of facts or submission of fake/ forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/ or to influence the procurement process to the detriment of the Government interests.
- 5) The Bidder(s)/ Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may be fall upon a person, his/ her reputation or property to influence their participation in the tendering process).

Article 3: Consequences of Breach

Without prejudice to any rights that may be available to the Principal/ Owner under law or the Contractor its established policies and laid down procedures, the Principal/ Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/ Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/ Owner's absolute right:

- 1) If the Bidder(s)/ Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/ Owner after giving 14 days' notice to the contractor shall have powers to disqualify the Bidder(s)/ Contractor(s) from the Tender process or terminate/ determine the Contract, if already executed or exclude the Bidder/ Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/ Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.

- 2) Forfeiture of EMD/ Performance Guarantee/ Security Deposit: If the Principal/ Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contractor terminated/ determined the Contractor has accrued the right to terminate/ determine the Contract according to Article3(1), the Principal / Owner apart from exercising any legal rights that may have accrued to the principal.

ADDITIONAL CONDITIONS AND SPECIFICATIONS

1. The interested parties must be capable of providing vehicle on their own on the following terms & conditions:
2. The chauffeur engaged for driving the vehicle shall always possess valid driving license issued by the R.T.A authorities. Registration Certificate of the vehicle, Insurance documents, No-pollution certificate etc., shall always be available in the vehicle.
3. The chauffeur shall have the Knowledge of TELUGU/ENGLISH and the conduct and character shall be good.
4. The chauffeur shall maintain the dress code as specified by the RTA authorities for hired vehicles.
5. All major / minor repairs for the vehicle shall be carried out by the agency.
6. In case of any break down of the vehicle, the contractor shall arrange an alternate vehicle within an hour of breakdown of the vehicle.
7. Necessary taxes, insurances etc., either to State / Central Governments/ local authorities shall be paid by the agency before their due dates.
8. The agency shall arrange the vehicle on all working days including holidays. The vehicle shall be arranged on Sundays, if the services of the vehicle are required by the Engineer-in-charge.
9. Log book should be maintained on daily basis in the proforma approved by the Engineer-in-Charge.
10. In case of any accident during running of the vehicle leading to injury or loss of life and damages to the vehicle, the contractor shall bear all the responsibility. The contractor shall settle all the claims arising out of such accidents and nothing shall be paid extra on this account.
11. Taxes as applicable shall be deducted from the running bills.
12. The vehicle should have Taxi Registration and bear on its front **"ON GOVT. DUTY"**.
13. The Driver shall accompany all necessary documents of the vehicle including up to date insurance, pollution certificate, road tax and registration certificate along with the vehicle.
14. If services and behavior and punctuality of time found not satisfactorily as reported by Officer using vehicle, the Engineer-in-charge can close the contract without giving any notice.

Standard Operating Procedures (SOPs) and
Guidelines for Construction Sites for
COVID-19 Outbreak

The following standard operating procedures and guidelines shall be followed at no extra cost:

A. General Guidelines:

1. Thermal Scanning of everyone entering and exiting constructions will be done for fever with thermal scanners. If anyone leaves and re-enters the site during the shift, re-screening of the individual will be done prior to re-entry into the work site.
2. PPE and Other material requirement shall be provided as per requirement.
3. Provision for hand wash & sanitizer (touch free recommended) will be made at all entry and exit points and common areas (including at distant locations like higher floors). Everyone will be required to wash & sanitize his/her hands before entering the site and using PPEs. Same procedure to be followed removing PPEs and exiting the premise. Enough of all the items should be available at the site.
4. All Protocol including Emergency Response will be laid out. Periodic tailgate sessions will be arranged to review site protocols in view of highly dynamic scenario ensuring social distancing norms. During these sessions, everyone including workers will be informed about the safety guidelines and important updates. Necessary arrangements for announcements shall be made at every site.
5. Mandatory use of PPEs (face mask, hand gloves and other as applicable) by everyone entering the premise. Re-usable PPEs should be thoroughly cleaned and should not be shared with others.
6. Entire construction sites including site office, labor camp, canteens, pathways, toilets, and entry/ exit gates will be disinfected on daily basis. The housekeeping team should be provided with the necessary PPEs.
7. There will be total Ban on non-essential visitors at sites (including from Head office staff, consultants etc.).
8. There will be strict ban on Gutka, Tambaku, Paan etc. onsite and spitting shall be Strictly Prohibited.
9. Food should be consumed at designated area as only ensuring social distancing.
10. Common sitting arrangements should be removed.
11. Post lunch, waste should be disposed of by individuals in designated bins and area should remain clean.
12. Areas with a probability of bigger gathering, for eg. cleaning area, toilets etc. should be identified and all arrangements should be made to ensure social distancing.
13. A doctor will be present periodically (at least once a week) at site on allotted time for any medical assistance.
14. Appropriate signage at construction site spelling out safety practices in the language which is understood by all.

15. Hospital/clinics in the nearby area, which are authorized to treat COVID- '19 patients, should be identified and lists should be available at Site all the time.
16. For any confusion, clarification and update, everyone should approach designated authority or rely on authentic source.
17. Rumors shall be discouraged, and offenders be warned.
18. An isolation room shall be created on site.

B. Guidelines for Workers:

1. Ongoing, before resuming the work on site post lock down period, mandatory medical check-up will be arranged for all workers. The workers coming from outside will be quarantined for a period of at least 15 days. Only medically fit workers will be deployed at site and medical assistance will be arranged for unfit workers. Medical checkup camp should be arranged every month.
2. The laborers staying at site will not be allowed to go outside. All the essential items will be made available to laborers at site only. If necessary, the workers can go out wearing PPEs, after informing the supervisor. Similarly, no outside labor will be allowed on site without following proper procedure and instructions.
3. Start time on site will be staggered to avoid congestion at the entry gates. The number of workers working at a particular time / place will be reduced by deciding for different shifts / areas. Accordingly, additional staff such as security guards, supervisors etc. will be deployed.
4. As in most cases, workers reside at the Sites, hence there is no need for any travel. For Workers staying outside, (which are always nearby) special transportation facility will be arranged without any dependency on the public transport system.
5. During attendance, training and other sessions, social distancing guidelines will be followed along with the provision of no touch attendance.
6. Workers should not shake hands when greeting others and while working on the site.
7. Workers shall avoid contact with sick people and avoid going to site if they are feeling sick, have fever, cough or shortness of breath. In such case, supervisor should be informed immediately.
8. Workers with such symptoms should not come to the site and should be placed in isolation and medical assistance will be provided on an immediate basis.
9. Mandatorily wear face masks while working on site. While not wearing masks, worker shall cover his mouth and nose with tissues.
10. Cough/sneeze should be done in the crook of one's arm and your elbow.
11. Avoid large gatherings or meetings of 10 people or more. Stay at least 6 feet away from others on job sites and in gatherings, meetings, and training sessions.
12. No more than 214 people (depending on size) will be allowed to travel in lifts or hoists. The use of staircases for climbing should be encouraged.
13. Workers should clean their hands frequently by washing them with soap and water for at least 20 seconds. When hand washing isn't possible, alcohol-based hand sanitizer with greater than 60% ethanol or 70% propanol should be used.

14. Workers should not share their belongings like food, water bottles, utensils, mobile phones etc. with others.
15. The utensils should be washed properly post use at designated place.
16. Post work, workers should change their clothes before leaving the site and clothing should not be shaken out.
17. Avoid touching your eyes, nose, or mouth with unwashed hands.

C. Guidelines for Material, Tools, Machinery, Vehicles etc:-

1. Wipe down interiors and door handles of machines or construction vehicles, the handles of equipment and tools that are shared, with disinfectant prior to use.
2. Non-touch waste bins with disposable garbage bags should be installed for waste collection at all common access areas.
3. Proper disposal of garbage should be ensured.
4. At all points of time, easy access to parking should be ensured since public transit is limited.
5. All construction material arriving at site should be left idle for 3 days before use to ensure safe usage.
6. All vehicles and machinery entering the premises should be disinfected by spray mandatorily.

Emergency protocol in case of detection of symptoms of COVID 19 to be observed by Project Manager of Contractor:-

7. Immediate shift worker to isolation room. Inform the Engineer-In-charge CPWD or his Nodal officer.
8. Call a doctor.
9. Keep the worker under observation for a few days in an isolation room. In case of doubt act per advice of local doctor.
10. Covid testing shall be arranged as per the instruction of Doctor and if so advised by Doctor move worker to Hospital.
11. Prevent rumors and take strict action against those who spread it.
