1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Experience Criteria, shall upload the supporting documents to prove his eligibility for Relaxation.
2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be relaxed from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be relaxed from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking Relaxation from Turnover, shall upload the supporting documents to prove his eligibility for Relaxation.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
5. **Purchase preference to Micro and Small Enterprises (MSEs):** Purchase preference will be given to MSEs having valid Udyam Certificate and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service, and Buyer will decide eligibility for purchase preference based on documentary evidence submitted in case of product bids, whereas in case of services the eligibility is automatically validated. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within $L-1+ 15\%$ (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 100% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated

on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -

1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or

1. Generic

OPTION CLAUSE 25% : The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, the contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration.

For lumpsum-based service contracts, the buyer may increase the scope of work and contract value up to 25 percent with the consent of the service provider

2. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. The bidder/contractor must upload all valid certificates and supporting documents at the time of tender submission. These include, but are not limited to: Vehicle Registration Certificate (RC), Insurance certificate (comprehensive), Road Tax receipt, P U C (Pollution Under Control) certificate, Fitness certificate, Commercial permits/licenses as per Motor Vehicles Act and RTO rules, Proof that the vehicle is owned by the firm/proprietor submitting the bidder, GST registration certificate, PAN card of proprietor/firm

2. **Vehicle provided should be owned by the proprietor/firm** and shall have all necessary permits and documents mentioned in Sl. No. 1 for providing commercial vehicles for this service. Place of Consignee is at Kollam.

Failure to upload all the above valid documents will lead to rejection of

the tender.

3. The rate shall be inclusive of driver, fuel, lubricants, and other running expenses. The maximum kilometre to run per month shall be as mentioned in the schedule. Any extra kilometre beyond the schedule shall be paid as per the respective item. The timing for operation of the vehicle shall be as per the schedule per month, and extra hours beyond the schedule shall be payable as per the schedule.

4. - In no case shall actual wages paid to the driver or workers be less than those stipulated by the Ministry of Labour of the State or Central Government, whichever is higher. All local labour laws shall be strictly followed. Any complaints received and proved shall be taken seriously and appropriate action under relevant clauses of the agreement shall be taken. The make of the vehicle shall be as specified; any change requires approval of the Engineer-in-Charge.

5. All types of repairs shall be carried out by the vehicle owner at their own cost. A daily record indicating time and mileage for the vehicle shall be maintained in a log book. All journeys performed for refueling, repairs, or during halts at out station from headquarters, including travel to and from the driver's residence or vehicle parking place, shall not be paid by the department.

6. Hire charges include monthly charges for driver, running of the vehicle, repairs and maintenance, insurance, diesel/lubricants up to 2000 km per month, and any other incidental expenses, including penalties, fines, or traffic challans. Nothing extra shall be paid on such accounts. For additional or fewer kilometres beyond or below the specified kilometre in the schedule per month, payment or deduction shall be made as per the rate quoted in the schedule of quantity. 7. In case of any breakdown, damage, theft, or accident, the vehicle owner shall provide an equivalent substitute vehicle immediately. Otherwise, a penalty of Rs. 1000 per day shall be imposed and recovered from the monthly running bill. In case of any accident, all claims arising from it shall be met by the vehicle owner agency. The owner shall be responsible for compensation payable arising out of accidents to third parties, if warranted. No compensation shall be paid by the department in case of damage to the vehicle or injury/death to the driver.

8. In case of loss of department property due to negligence on the part of the driver, such losses shall be borne by the contractor. The vehicle shall be kept neat and clean and maintained in perfect running condition by the vehicle owner.

9. The driver shall have a valid driving license and the vehicle shall be registered with the concerned authority of Central or State Government. A certificate to that effect shall be provided. The driver must follow all traffic rules and regulations at all times. The contract may be cancelled by either the department or the contractor with a notice period of 15 days. A penalty of Rs. 1000 per day may be

e levied if the vehicle fails to meet the terms and conditions. In case of frequent violations, the contract may be cancelled forthwith without notice.

10. The driver shall observe all etiquette and protocol while performing duty, shall be neatly dressed in white uniform, and carry a mobile phone in working condition, for which nothing extra shall be paid. The vehicle shall have two sets of loose white seat covers for alternate use, changed every 4 days or as required. Cleaning costs shall be borne by the vehicle owner. The vehicle shall be kept neat, clean, and in perfect running condition with adequate fuel, seat covers/towels, and sufficient space in the boot for luggage.

11. Toll tax, entry tax at barriers, other state road taxes, and parking fees shall be reimbursed as per actual expenses. If the vehicle remains absent for any reason, the controlling officer reserves the right to hire another vehicle from the market for that day. The hire charges shall be recovered from the contractor, or the contractor shall arrange an alternate vehicle at their own risk and cost. Repairs, if any, shall be borne by the contractor. The department shall not be responsible for any repairs or maintenance. All expenditures incurred for running the vehicle, maintenance, repair, or repair due to any accident shall be borne by the owner/contractor. Nothing extra shall be paid on any account. The driver shall maintain decent and polite behaviour. If the Engineer-in-Charge is not satisfied, the agency shall change the driver. Nothing extra shall be paid for the change. Any fines due to traffic violations shall be the liability of the owner/contractor. Nothing shall be paid or borne by the department.

12. Arrangements for different drivers shall be the responsibility of the owner/contractor to ensure driver availability on all days including Sundays and holidays. Change of driver shall not be allowed except under exceptional circumstances with permission from the Engineer-in-Charge. The department reserves the right to cancel the tender without assigning any reason, in the interest of the government. Road tax and insurance shall be borne by the contractor. Nothing extra shall be paid. All vehicles provided shall be air-conditioned and equipped with an emergency medical first aid kit and a fire extinguisher. All vehicles shall be in excellent working condition internally and externally at all times. The contractor shall ensure that vehicles are thoroughly cleaned internally and externally, and the boot is kept clear of dust, rubbish, oil, bad odour, or any personal belongings of the driver.

13. Drivers must possess a valid driving license and have a minimum of 2 years of driving experience. The contractor shall ensure that all maintenance works related to the assigned vehicle are carried out during off-duty hours. All electrical connections, including lights, horn, turn indicators, air conditioning, and other vehicle systems, shall be periodically checked and maintained by the vehicle owner.

अस्वीकरण/Disclaimer

The Additional Terms and Conditions (ATC) have been incorporated by the Buyer after approval of their Competent Authority. The Buyer, is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any restriction arising in the bidding process due to these ATCs and including the modification of technical specifications and / or terms and conditions governing the bid. All representations / grievances pertaining to the ATC clauses shall be raised with the buyer organization directly and not with GeM. If any of the clause(s) is/are incorporated by the Buyer regarding the following, the bid & resultant contract shall be treated as null & void. Further, GeM reserves the right, at its sole discretion, to cancel the bid forthwith, without issuance of any prior notice or intimation :-

1. Publishing Custom / BOQ bids for items for which regular GeM categories are available (unless such Custom / BOQ item is bunched with the major regular product Category Item).
2. Mandating procurement of / from specific Brand / Make / Model / Manufacturer / Dealer except in case of Single Bid / Proprietary Article Certificate (PAC) Buying.
3. Inclusion of disqualification criteria related to suspension of seller / service provider, where such suspension period has already expired.
4. Mandating submission of documents (other than EMD and signed Integrity Pact - which can be submitted within 5 days of bid opening) in physical form as a pre-requisite to qualify bidders.
5. Publishing bids on GeM for procurement of works.
6. Procurement of Goods by creating a Service bid on GeM & vice-versa.
7. Seeking sample with bid or approval of samples during bid evaluation process. However, trial / sample, as the case may be, shall be permitted in cases where trial / sample are allowed as per approved and published procurement policy of the Buyers' controlling Ministry / Department / State / Public Sector Enterprises Headquarters. If there is any violation of trial / sample clause with regard to approved policy of the Buyers' Ministry / Department / State / Public Sector Enterprises Headquarters, then this is to be determined and redressed by the concerned Buyer Organisation only.
8. Seeking experience from specific organization / department / institute only or from foreign / export experience.
9. Creating bid for items from incorrect categories.
10. Reference of conditions published on any external site or reference to external documents/clauses.
11. Asking for any Tender fee / Bid Participation fee, as the case may be.
12. Buyer added ATC Clauses which are in contravention of clauses defined in bid detail section, including specifications, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by the applicable GeM GTC.
13. Any ATC clause in contravention with GeM GTC Clause 4 (xiii) (h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
14. In a category based bid, adding additional items, through buyer added, additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogues or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules)

shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
